At a County Court held for Madison County on Monday the 2^d day of February 1829. This settlement with Ralph McCreary of North Street died was returned and ordered to be Recorded and the same has been duly Recorded in my office

Accordingly to an Order of the Worshipful the County Court of Madison County directed to divide the lands of James Gales deceased between his heirs who have appeared to do so being first sworn A.B.C.D. Containing 86 acres of land is this land which we have divided as follows (To wit)

Beginning at a Stake Corner to the Madison rights of Doverland and in Richard's lot between his line and his line at 83 & 81 poles to a white oak and black walnut corner to Isaac & Henry and James McWilliams and B. Chene with a line of 100 McWilliams 116 118 poles to a white oak tree at C. Isaac McWilliams' corner thence with another of his lines 55 1110 poles to a black walnut stump another corner of the Doverland at D and with the same 22 & 109 poles to the Beginning at E (We have attached to Supplement taken Containing 15 acres Bound as follows (To wit)

Beginning at a Stake at E. Chene with the lower line at 22 1119 poles to the Corner at a black walnut stump thence with the same line at 22 & 143 poles to a Stake at F. Chene 63 to 16 poles to the Beginning
