kind have come to my hands as yet as Guardian for said
heirs that I have contacted and kept Montgomery C. Thompson
from the first of March 1823 to the first of March 1826 except two
months that he was in Fayette County last paid to his friends
also I furnished him books and clothes during the year
the balance was furnished gratis by his friends my charge for
board the two months, together, with making his clothes furnishing
and washing the same \$20.00

Also he has been kept and like manner
and furnished from first March till this time
August 1st by and for which I charge, \$15.00

Also keeping William Thompson in the above
manner and furnished from first March 1823
till first March 1826 at two dollars per month \$24.00

Doct. Griffiths medical bills paid by and for
himself to said William as per bills listed show \$19.00
