

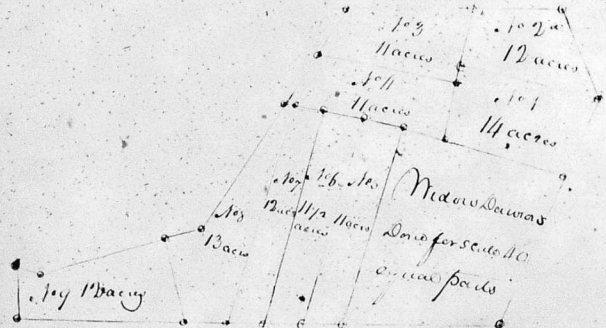
190 March Court 1812
