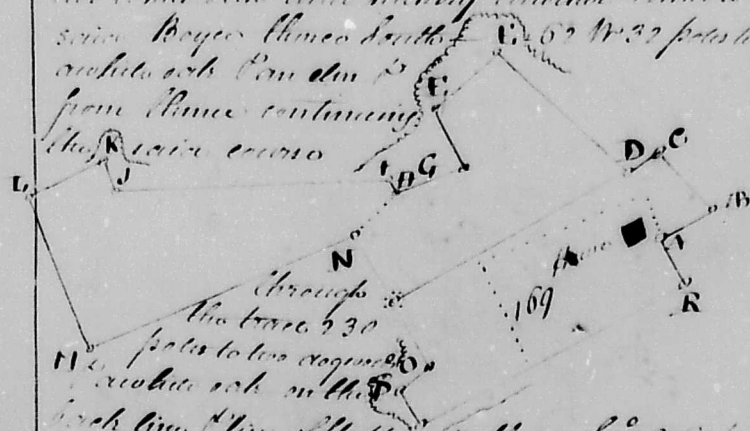

 true which I fear the loss of conscience will
 be a large part of my property in the hands
 of said Palmer. I have expressed in every
 giving to it, with the hope of the content to be
done or be the not complete with his part in
no respect. The other comes to be divided
equally between the leges my Heirs and the
 property to be raised or content for the benefit
 of said Boys I do appoint Henry Palmer and
 Thomas Leges my executors
