Knowing that it is ordained for all men to die
do hereby make constitute and ordain this to be
my last will and testament hereby revoking dis
annulling & making void all Wills Testaments
or bequeaths & heretofore made by me viz
I promise I give and bequeath unto my dearly
and well beloved wife Hannah the use and benefit
of the Plantation on which I now live on situate
on the waters of Salt river as long as she thinks
proper to remain a widow and together with
the stock and household furniture now then on
and likewise the Appurtenances there unto belonging
& if in case she marries then the Aforesaid plant
ation stock and house hold furniture is to be
valued and sold at Publick Vendue according to
Law and she is to have the one third of the amount
of the Sale thereof the remaining part thereof to be
equally divided between the whole of my Children then
living I Give and bequeath unto my Eldest son
Isaac my negro slave Bristol and likewise I bequeath
unto my son John my negro slave June the above mentioned
negroes to be had out until my said son pay the
wages or hire of said Negroes is both appropriate and sufficient
for the purpose of schooling said Children and the support

In the name of God amen I Adam
Smith of mepher County and state of
Kentucky being perfect in mind and memory
though weak in body calling to mind the
mortality of my body knowing that it is
appointed for all men once to die do
make and ordain this my last will and
Testament in the following manner (viz)
as Touching such worldly goods as it hath
pleased god to bless me with First I Order
that all my just debts and funeral Charges
be paid Also order that one hundred Acres of
this land of this tract I now claim on
the upper part of it to be sold the money
arising from such sale to discharge my just
debts I give and bequeath to my beloved
wife Elizabeth my house plantation and
Land where I now live on during her life and
after her death to go to my son
Ezekiel his heirs and assigns for ever also I
order that my son Ezekiel after his death
of his mother to give to my son Benjamin
his brother fifty Acres of this Land on the
water there of his money which he then shall
have Also I order my son Solomon fifty Acres of this Land on
the water there of in money which he then shall
have I give and bequeath to my son
wife all my moveables Estate my Negro
girl Rose also my Negro boy George

George to be holy at her disposal during her
life and after her death the Negro girl
Rose to go to my daughter Elizabeth and
the Negro boy George to my son Ezekiel
to his heirs and assigns for ever and I do

beloved wife Elizabeth and my son Ezekiel
Executors of this my last will and Testament
also I do hereby revoke make void and
disannul all former will or wills by me made
and do pronounce and declare this to be my
last will and Testament in witness whereof
