I Oath

I Robert Mosby of Mercer County State of Kentucky doth make this my last will & Testament in manner & form following (to wit)

I give and bequeath unto Elizabeth England three hundred dollars to be paid to her as hereafter directed also a good riding horse two good cows to her and her heirs forever.

I give and bequeath to Polly Humble consort of Noah M. Humble and daughter of David Mosby deceased the following slaves (to wit) Minny & her two children Paddy & Joe which said negroes or slaves are now living with her, to her the said Polly and her heirs of her body forever but should the said Polly die without leaving such heirs of her body

265 it is then my will that the said Negroes
go to my Nephews William & James Mosley
sons of my Brother John to them & their heirs
forever. I also give to the said Polly on her death.
I give Sluquath to John Hannon of Garrett County
the following slaves (to wit) Ralph, Eliza, Jimmy,
Joe, Landon, and Phile with their future
increase to him & his heirs forever which
said slaves I have already delivered to the said John
to Robert Mosley son of my Brother John.
I give and bequeath the following slaves to wit,
Dick, Lucinda, Sucky, America, & Nancy
to him and his heirs or assigns forever
on condition that he the said Robert pay
or cause to be paid unto the above named
Elizabeth England three hundred dollars,
the sum above given to her.

It is my will that my following slaves
be free as if free born (to wit) old Charles
and Milly his wife, old Bob & Phile his wife
all the residue ^{Deming} of my ^{estate} ~~property~~ both real
personal of every kind and nature, I give
and bequeath to Robert Mosley Junr
son of my brother Samuel Mosley deceased
to him and his heirs or assigns forever,
out of which it is my will that all my
just debts be paid. and it is further
my will, that the said Robert son of
Samuel out of the estate herein given to him

266 support in a comfortable manner, the slaves above
mentioned to be free from the time that they or
either of them shall from age or infirmity become
incapable of maintaining themselves. Lastly
I hereby appoint my Brother Joseph Mosley
and my Nephew Robert Mosley son of Samuel
Mosley decd. Executors to this my last will & testament
hereby revoking all former wills by me made,
and I do hereby authorize and empower my said
Executors or such of them as shall chuse to act, to settle
and adjust all disputes & other matters relative to
my said estate in such way as they or either of them
acting may think most advisable, and having full
faith and confidence in them, my said Executors,
it is my will they or either of them ~~my~~ acting,
administrate upon my estate under the provisions
of this will, without giving security, as the law in
such cases directs. witness my hand & seal this 5th
day of February 1815. Robt. Mosley. ~~Decd~~
