lands and Slaves which was shewed to us
as follows his portion of the farm 19 1/2
acres including the Building, all over
the Barn and land to include the orchard
Beginning at a Sugar tree stump it being
the North East Corner of William R. Smith's
Premises, Thence with his line North 88
West and with the line of Cook & Smith
Premises One hundred and twenty four
poles to a pair of Barn, Thence South 88
West twenty five poles to a stake
Thence Eastwardly to a stake, in Wm.
Calks line, length five poles with the

West from the beginning, Thence to the be-
ginning. Also one Negro girl named Nell
valued at Sixty Six pounds, and also one girl
named ~~Lou~~ Nott valued at Thirty pounds
which bears a difference of Six pounds which
the heirs of the Deceased is to pay to the Widow
which then makes the third part of the
Negroes, the whole of them being paid
to three hundred and Sixty pounds.
