I first recommend my soul to almighty god who gave it, trusting in the merits of my saviour to receive forgiveness of all my sins, and what worldly goods the Lord has been please to bestow on me after my just debts is paid and funeral expenses. I give and bequeath in the following manner Namely I give unto my son John Duan one half have both now and year due for the use of his son Thomas Duan.

Item 2. I then give unto my son Richards Dean all the rest of my Estate consisting of house hold furniture, horses cattle hogs with all my personalty, slaves, and I do appoint and ordain my Son Richards Dean my full and sole Executor to this my last will and testament. Given under my hand and signed by me this 7th of May in the year of our Lord 1810. in the presence of—

William Wright

At a County Court held for Nelson County on Monday the 16th day of
December 1844

This last will & testament of John Dean was proved by Anthony Trina one of the subscribing witnesses thereof & ordered to be recorded the other witness not being an Inhabitant of this State.
