Item 1st Having the great last regards for my affectionate wife Polly Graycraft I order and appoint her my Executrix, and my brother E. Graycraft Executor of this my last Will, to transact and settle all my worldly business which I may leave unsettled.

Item 2^d I wish to be buried in a decent Christian manner

Item 3^d I wish and bequeath to my affectionate wife Polly Graycraft all my house hold and kitchen furniture, farming utensils together with all my personal property, also my land and my negro girls Emily during her widowhood for the use of herself and my children.

Item 4th In case my wife Polly should survive during her widowhood then and in that case, I wish and desire that my Executors E. In the name of Lord Amen! I Daniel Smith of the County of Nicholas and State of Kentucky Being weak in body but of sound mind and disposing memory and calling to mind the uncertainty of human life, and being desirous to dispose of all such worldly estate as it hath pleased God to bestow upon me, I give and bequeath the same in manner following. 1st After my decease I wish all my debts of every description that may be fairly and justly brought against me including my board and nursing, with my burial expenses, shall be paid. Item 2^d I give to my daughter Mary Brown one hundred & fifty dollars. 3^d To my daughter Nancy Williams I give one hundred and fifty dollars. 4th I give one hundred and twenty dollars to Mary Smith, widow of my son Nathan Smith to be put to the use of schooling the children of my son Nathan Smith.

5th I give to John Smith my bed and its furniture, and my wearing clothes to be to my two grandsons John Dickerson and Nathan Dickerson I give the residue of my estate. And lastly I hereby appoint John Smith the executor of this my last will & Testament, working all others. In Witness my hand and seal this 1st day of May 1837.
