The said Adm^r presents to us two promissory notes executed to him
 by the Decedent in March 1833 amounting to \$84.37 1/2 each,
 besides the interest thereon, which will more than cover the balance
 due the estate: and we report therefore, that when these notes
 are set off against the said balance, there will be due to the estate
 the sum of \$18.40. We further report that Elizabeth Caldwell
 (as appears from Voucher No 5. herewith returned) claims and got from
 said Adm^r personal property to the amount of \$148.20 which she
 claims as the widow of the Decedent: and which we find to consist of
 such articles, to which she was entitled, by virtue of such right.
 This amount is not included in the sales bill, all of which
 we respectfully submit to the Court.

Vinc^l on the above settlement the said Adm^r has recovered on
 judgments against James M. Hatfield for \$25. & \$2.50, attorney fees
 in a suit brought for the recovery of the value of a negro; which amount we report
 against said Adm^r being the sum of \$27.50. and allow him for counsel
 employed in said suit the sum of \$10.00 leaving a balance of \$17.50
 which is left them the balance due the Adm^r in liquidation of his report, to wit:
