I. an equal share thereof to be paid to them respectively as they arrive at 21 years of age and on the death of my beloved wife, then I give and bequeath to them all my lands contained in my aforesaid two tracts to be equally divided between them, but should any of aforesaid children die, then in that event the share of the dead child or children shall go to my said children that are surviving at the reversion of my said land.
