

## Last Will and Testament

I, LEXIE ROGERS, a widow, of Somerset, Pulaski County, Kentucky, being of full age and of sound mind and memory, do hereby make, publish and declare the following to be my last will and testament, hereby revoking any and all wills by me heretofore made:

ITEM 1: I direct that my just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my decease, except I direct that my life insurance made payable to Allie Dean Rogers Littrell be used to defray as much of the above expense as possible.

ITEM 2: I desire to be buried with a casket similar to the one in which my late husband, Ed Rogers, is buried.

ITEM 3: I direct that my daughter, Allie Dean Rogers Littrell, keep my jewelry until my grandchildren are old enough to properly take care of the same and that she then distribute my white gold diamond ring to my granddaughter, Sarah Jane Littrell; my yellow gold diamond ring to my grandson, Roger Littrell, and my other ring to my grandson, David Scott Littrell. My daughter may either keep my wedding ring or bury me with the wedding ring.

ITEM 4: I give, devise and bequeath all the remainder of my estate, whether same be real, personal or mixed, and wheresoever situated, one-half to my daughter, Allie Dean Rogers Littrell, and one-sixth to Sarah Jane Littrell, one-sixth to Edward Roger Littrell, and one-sixth to David Scott Littrell, to be theirs absolutely and in fee simple, subject to the control in the same hereinafter vested in my daughter. My daughter, Allie Dean Rogers Littrell, shall have full authority to sell and convey any and all real estate which I may own at the time of my death and to reinvest the proceeds from the same in other real estate, securities, or deposit the same as she may deem fit. She shall have the right to use the corpus of the estate bequeathed and devised to my grandchildren for their health, education and welfare until they attain the age of twenty-one years, at which time she shall pay over the remainder of said children's share to each of them as they attain their majority.

I request that Allie Dean Rogers Littrell retain on deposit in a bank a sufficiency of her share of my estate to keep her own life insurance paid up from time to time in order that her children shall receive the benefit of her life insurance which I have carried to this time.

ITEM 5: I nominate my daughter, Allie Dean Rogers Littrell, to be the executrix of this, my last will and testament, and direct that she be permitted to serve without bond and that no inventory nor appraisal be made of my estate in so far as the same may be lawfully omitted. In the event that my daughter should fail to qualify as executrix, I direct that she have the authority to designate the executor whom she desires to serve as my personal representative. Nothing herein contained providing for the appointment of an executor other than my daughter, Allie Dean Rogers Littrell, shall be construed as any limitation on my daughter's unlimited right to sell and convey any real estate and to receive all of my estate for her benefit and the benefit of her named children as hereinbefore set out.
