MACKAY, Hugh, Certified copy of his LWT of Parish of St. Ann in
Co. Middlesex, Jamaica, West Indies, dtd 6/11/1763 names bro.,
John of Strathy, Scotland, 4000# on condition that he convey to
John Gordon of St. Mary's Parish in Jamaica and Hugh Mackay of
the same place, two of exrs of LWT, all of said John's interest
in any lands of testator which deed may have deeded to said John.
If John refuses, then 1/2 of money to be paid to children of John
Sinclair, late of Scoto, Caldwell, in Scotland to be divided
between said children by their mother (testator's sister) and
other 1200# to be paid testator's brother, James Mackay of
Georgia; also his interest in Ga. Lands. Niece: Barbara Mackay,
Wife of James. 19/6/1763. Georgia Colonial Deeds, Misc. Bonds, Bk

MACKAY, Isabella, widow of Hugh, Lord Reay, late of Sapelo

first LWT. David Montague and James Mackay, exrs of her 2nd LWT.
Isabella Mackay of Sapelo Island, LWT dtd 6/19/1777, probated
11/11/1783, states that prior to her marriage to Patrick Mackay
she conveyed all her property to Hector Berenger DeBeaufort as
her trustee and that she has since the death of her husband
(whose LWT is dated 6/6/1768) recd other property. She devises to
son, Samuel Montague; grandson, Peter Samuel LaFitte, minor;
Isabelle Mackay Stewart, dau. of Capt. James Stewart of
Philadelphia; Isabella Mackay, dau. of Daniel Mackay of Sapelo
Island; Miss Winewood McIntosh of Mallow; friend, James Mackay,
"a relation of Patrick, decd." Remainder of est. to her oldest
son, David Montague to be in trust by him and James Mackay as
trustees. Niece: Susannah, Lady Dowager St. John of Betsol or
Bletsol, wife of Lord St. John of Bletsol. From Colonial Deed Bk
J, appraisement of the negroes of Est. of Peter LaFitte done at
request of Mrs. Isabella Mackay, creditor and Peter LaFitte, co-
heir and atty for his brother, David, now in England 4/27/1750.
Colonial Deed Bk J, p. 493-4, Peter LaFitte of Granville
S. C. deeds to Isabella Mackay 7/2/1751, co-heir of est. of
Peter, decd. and atty, David, bro. of former "now of England" to
Isabella, creditor, 3 negroes. Patrick Mackay, atty, apptd by
Isabella 4/27/1750.

C., merchant, in trust for said Mrs. Ann Mackay to Grey Elliott of Savannah 11/2/1766, 500 acres in Dist. of Great Ogeechee, W by town of Hardwick, granted 9/8/1756 to said Savage in trust for said Ann. Georgia Colonial Deed Bk 83, p. 5.

MACKAY, James of Strathey Hall in Chatham Co. deeds to his grandchildren, viz: John and Ann Kelsall, children of his dau., Barbara and her husband, Roger Kelsall (said Barbara being deed) 5/7/1784, 34 slaves. Chatham Co., Ga. Deeds, Bk 1-A, p. 72.
