I volunteered to go. was accepted and went first to Lovejoy, then to Savannah, where I joined the Siege Artillery. Our company made up at Thunder Bolt, and we left for Dalton, Ga. From Dalton we marched to Franklin, Tenn. where we had a skirmish and won. From Franklin we went on to Nashville. I was in two battles. The Battles of Cheatham's Hill and the Battle of Kennesaw. During the Battle at Kennesaw there was a fellow named Tom Gook who was killed right beside me...I was not in the battle of Atlanta....Mr. Reid was of Irish descent, his father having come to America from Ireland

when a boy. There were four girls and two boys in the family and they were reared in Benry Co., Ga. In early manhood, Mr. Reid married Miss Mary Wheeler of Woodbury, Ga. and they made their first home at Tyrone in Fayette Co. Later they moved to Kenwood...Mrs. Reid passed away in 1917. Templeton Reid's father, Alexander, and four of Alexander's brothers, fought in the Revolution and after the war all qualified for bounty lands in Georgia...Five families moved to the Greene Co. area between 1786 and 1792. Alexander farmed, operated a ferry over the Oconee, and with John Garner owned a grist mill on the river near the crossing of the Eatonton-Greemsboro Rd. The history of Greene County states that Teaplton was born in 1789, when his father was 63 years old. This

does not agree with his age as it was reported at the time of his death. The sexton's report would have him three years older, that is, born in 1786. Alexander died in 1807 and his will does not mention Templeton by name, although it does provide for five unnamed winor children. This would lead us to believe that the 1789 date is correct as Templeton would have been a minor at the time of his father's death.... In the summer of 1830 he came to Gainesville...
