ADAMS, Richard b. ca 1730, came to Richland Co., S. C. in 1770, listed as an early landowner in History of Richland County by Edwin L. Green, ie.: "Richard Adams, 150 acres, Sep. 10, 1770." From South Carolinians in the Revolution by Ervin: "the following is a list of persons who received pay for clothing - who are not included in Sumters list and special bounty: Richard Adams, et al." The LWT of Richard Adams dtd 10/28/1778, probated 2/19/1788, Richland Co., S. C., WB B, p. 19, names wife, Mary, and son, Abraham Adams, as exrs. Also ch: Annes Gregory, John Carroll Adams and Richard Adams (left property in Beaufort Co., N. C.), and Abraham Adams. Children not named in LWT were: William and James, substantiated by LWT of son, Richard Adams, WB, Richland Co., S. C., p. 45, dtd 1/11/1803, probated 1/2/1807, naming ch: William Adams and Rachell Bryson. Wife: Jane, and four brothers: John Carroll Adams, William Adams, James Adams and Abraham Adams. Bro-in-law: John Bryson.

ADAMS, Richard, son of John Carroll Adams, b. 1796 Richland Co., S. C., removed with his parents to Beaufort Co., N. C. to settle on lands which his grandfather (Richard) bequeathed his father. He apparently married Catherine either in Beaufort or Jones C., N. C., prior to 1820. In 1821 he drew in the Ga. Land Lottery, a res. of Hall Co., land in Houston Co. which he never took up. Listed on 1820 Ga. Hall Co. Census. In 1832 Ga. Land Lottery he was a res. of Clarke Co. From 1832-1834, he was res. of Jones Co. 1834-6, deed transactions were found for him in Muscogee Co. Listed on 1840 Twiggs Co. Census, 1850 Muscogee Co., and 1860 Chattahoochee Co., Ga. Census records. History of Twiggs County, p. 36, Twiggs Co. Cavalry attached to 37th Regt. names as reported by Capt. Harrison opposing the Twiggs Co. Cavalry who enlisted on 2/4/1836 - Richard Adams.

ADAMS, Samuel. There are two Samuel Adams on the 1790 and 1800 Censuses of the Tar River area in North Carolina who had sons. A Samuel Adams is on a North Carolina Revolutionary roster.

ALDRIDGE, Nathan listed 1790 Abbeville Co., S. C. Census, 96th Vist. One son over 16, 4 females, 2 slaves.

ALDRIDGE, Nathan, Jr. listed 1790 Abbeville Dist., S. C. Census, 96th Dist., 2 sons under 16, 2 females, no slaves.

ALLEN, Anne, dau. of Robert, b. 4/16/1726 St. Peters Parish Register, New Kent Co., Va.

ALLEN, Drury b. ca 1700, of Granville Co., N. C. 1759 and 1768 m. Elizabeth. LWT of Mrs. Elizabeth Stokes 4/27/1746 Lunenburg Co., Va. has witness: Drury Allen. Issue: Mary Allen m. Lyddall Bacon; David Allen of Johnson Co., N. C. in 1759; William of Lunenburg Co., Va. in 1759, land in Johnson Co., N. C. also; Drury, LWT dtd 1797 Brunswick Co., Va. names wife, Margaret and heirs: Eskandah, James Ranaldson, Drewry Allen Ranaldson, Mary Moore and Nancy Moore.

ALLEN, Elizabeth, dau. of William and Bridget, 4/26/1746 Overwharton Parish, Stafford Co., Va.

ALLEN, George b. 12/3/1754, Overwharton Parish, Stafford Co., Va.

ALLEN, George, son of Richard, b. 10/25/1721 St. Peters Parish Register, New Kent Co., Va.

AXLEN, Hannah, dau. of William, baptisted 9/17/1717, St. Peters Parish Register, New Kent Co., Va. She died 3/22/1719.

ALLEN, Jacoby, dau. of Robert and Elizabeth, b. 7/16/1728 St. Peters Parish Register, New Kent Co., Va.

ALLEN, James and Benjamin, sons of Robert, b. 4/12/1711, St. Peters Parish Register, New Kent Co., Va.

ALLEN, James, son of William and Bridget, 1/2/1744 Overwharton Parish, Stafford Co., Va.

ALLEN, John, son of Archibald and Abigail 8/12/1743 Overwharton Parish, Stafford Co., Va.

ALLEN, Judah, dau. of Robert, b. 7/31/1724, St. Peters Parish Register, New Kent Co., Va.

ALLEN, Judith, dau. of Samuel, b. 8/16/1716, St. Peters Parish Régister, New Kent Co., Va.

ALLEN, Margaret b. 9/8/1743 Overwharton Parish, Stafford Co., Va.

ALLEN, Margaret, dau. of Robert and Elizabeth, b.  $4/2^{9}/1734$ , St. Peters Parish Register, New Kent Co., Va.

ALLEN, Richard d. 7/6/1725, St. Peters Parish Register, New Kent Co., Va.

ALLEN, William b. 1/31/1741 Overwharton Parish Register, Stafford Co., Va.

ALLEN, William m. Bridget Withers 2/15/1743 Overwharton Parish Register, Stafford Co., Va.

ALLISON, William listed 1850 Iredell Co., N. C. Census, p. 461, 33, N. C., Elizabeth 28, Thomas J. 1, William M. Stevenson 22, Mary Allison 66, Elenor White 69.

ANDERSON, James. LWT, Surry Co., Va., dtd 1752, names issue: James, John, William and Thomas, brothers, who removed from Va. to S. C. after the American Revolution.

ANDERSON, James, b. ca 1690/1700, prob. Prince Geo. Co., Va., lived New Kent Co., Va., m. Mary Jordan, the dau. of Mary (Browne) and George Jordan (1657-1718), in a deed of 1718 from Prince Geo. Co., Va., sold to Joshua Meacham of Surry Co., 104 acres, for 4 pds., land near Nottaway River. 2/14/1719 James Anderson of Surry Co., Va. sold to Cornelius Cargite of Prince Geo. Co. for 10 pds., 105 acres on Cattail Swamp in Prince Geo. Co. James Anderson m. (2) Rebecca, the dau. of William Cook of Surry Co., Va. His death in 1752 was reported by Thomas Bedingfield in Albemarle Parish Register, p. 64. His LWT dtd 1/9/1751, probated 1/21/1752, Surry Co. WB 1732-34, p. 745, "James Anderson, of Parish of Southwark, Surry Co." bequeathes to sons, Thomas, James, John and William (William not 21). Daus: Mary (Mrs. Edward Eppes), Lyddy Averiss, Priscilla and Faith Anderson. Wife: Rebecca. Southside Virginia Families by Boddie, Vol. I, p. 296-7: "In South Carolinians in the Revolution by Sara Sullivan Ervin, John Anderson, William Anderson, James Anderson, and Thomas Anderson filed Revolutionary War claims in Camden District, later Chester Co., S. C. James and Thomas appeared to be brothers. James, Sr. and his sons - John, James and William and probably Quinton - moved from the Chester area to Greenville, acquiring lands in Norse Creek, while William had lands on Rabun and Lick Creeks."

ANDERSON, John, son of John, was b. 1759 in N. C., served as Pvt. in N. C. Militia, Rev. War. After war, he removed to S. C., first Camden Dist., then Greenville Co. He d. Telfair Co., Gr. 1849. Wife was Mary. South Carolinians in the Revolution by Sara Sullivan Ervin states that John, James and Thomas Anderson filed Rev. War claims in Camden Dist., later Chester Co. James and Tom appeared to be brothers. James, Sr. and his sons, John, James and William, and probably Quinton, removed from Chester erea to Greenville Co., acquiring lands on Horse Creek, while William had lands on Rabun and Lick Creeks. 1790 Greenville Co., S. C. Census lists John Anderson, one male over 16, 2 males under 16, 3 females. Pioneers of Wiregrass by Folks Nuxford, Vol. 5, p. 7: "John Anderson was b. 1759 N. C. He served as a Pvt. in N. C. Militia in Rev. War, residing at that time first in Duplin Co., then Bladen Co. After the war, he moved to S. C. His wife, Mary, was b. ca 1765. All children were b. in S. C., except the last one (Charles)." John Anderson d. 10/1849 in home of his son, Vincent, Telfair Co. who had moved there ca 1822. Now considered Toombs Co. Issue of John and Mary: Vincent Anderson b. 1788 S. C., d. Telfair Co., Ga. 10/1852 m. 5/8/1813 Sarah Copeland (b. 1792 Ca.), dau. of Robert Copeland; Rebecca b. 1790 S. C. m. Abner W. Sweat; Brice b. 1793 S. C., listed as petit juror Tattnall Co., Ga. 1810, reed headright grant in Tattnall Co. 1826; Argent b. 1795 S. C. m. 11/24/1816 Isaac Taylor, Tattnall Co.; Amos b. 1797 S. C. m. Martha Wood, dau. of Thomas Wood; Mary b. 1800 S. C. m. Aaron Daniel 8/25/1825; Elizabeth b. 1803 S. C. m. Tarleton

Knight; Charles b. 1808 Ga. m. Ann Cherry Daniel 10/2/1836, dau. of Aaron Daniel, Sr. in Tattnall Co.

ANDERSON, John, aged 20, onboard ship "Bonaventure" 1/2/1634, bound for Virginia. John belonged to House of Burgesses 1685-6 from York Co., Virginia. Colonial Virginia Register by William G. Stanard, Assembly of 1685-6, York Co., P. 85-6.

ANDERSON, John, son of James, b. ca 1730/40 in Virginia, m. Sarah Carney in Overwharton Parish, Stafford Co., Va., 11/25/1752, where their three oldest children were born: Bailey, Scarlet and Sela. During the Rev. War, the family passed through N. C., and afterwards settled on Pacolet River, Greenville Co., S. C. Sarah, widow, resided in Greenville Co., S. C. in 1790. Census as follows: Sarah Anderson, male 16 and over, 4 males under 16, 3 females. South Carolinians in the Revolution by Sara Sullivan Ervin states that John Anderson was a Minute Man entitled to 250 acres of land in Ga. bounty. However, this could be John Anderson, b. 1759. The book states that Sarah, the widow of John Anderson, drew his pension in 1786. Issue: Bailey b. 11/13/1753 Va., Scarlet b. 11/13/1753 Va., Sela b. 3/1/1758 Va. or N. C., John b. 1759 N. C., and others.

ANDERSON, Matthew obtained a land patent in Gloucester Co., Va. in 1790 for 8-1/2 acres of land, going to an old line of Capt. Anderson's (Robert Anderson, son of Richard).

ANDERSON, Richard, Sr., son of John, of Watford, Herts, England, yeoman. Richard Sr. and his son, Richard Jr. booked passage out of the port of London 7/4/1635, Richard Sr. travelling onboard the ship "Merchants Hope," and Richard Jr., age 17, onboard the ship, "Transport." Destinations: Virginia. This places the date of birth of Richard Anderson as 1585. He m. 12/20/1611 Elizabeth Hawkins, the dau. of William Hawkins, decd. A Monograph of the Andersons, Clark, Marshall and McArthur Connection by Thomas McArthur Anderson (1899): "Ten years before this date (1635) Thomas and John Anderson, two Englishmen, came to Jamestown in the ship, Bonaventure. The next year there came Richard Anderson, aged 50, in the ship, Merchant Hope. He was probably the father of Thomas and John, as Richard has been a family name in this branch ever since... The tradition that the founder of the family was Thomas Anderson of Northumberland, England, who settled as a shipwright at Gloucester Point comes from <u>Nistory of Virginia</u> Andersons published in Richmond in 1881 by Mr. Brock....I received my opinion from a Colonel Robert Waller, ... he told me that in his student dayhs he had gone to William and Mary College with a relative of mine and that he had long been familiar with our family history. He said that the first Virginia Anderson was a shipwright at Gloucester Point. About the same time, General William Tollieferro pointed out a place on the west shore of the Chesapeake which he said had been the first home of the Andersons." Therefore, while John Anderson lived in York Co., Thomas Anderson lived at Gloucester Point, across the York River from York Co., Virginia. The Point is across from Yorktown. Richard Anderson, Jr., of course, lived in York and Gloucester Co.'s, also, across the York River from New Kent Co., where the former's son, Robert Anderson, died.

ANDERSON, Richard, Justice of the Peace, King and Queen Co., Va. 1699 and 1702.

ANDERSON, Richard. In admn of Estate of Henry Lee, 10/26/1657, payments were made to Richard Anderson for 570 pounds of tobacco, York Co., Va.

ANDERSON, Richard, Sir. LWT dtd 10/5/1630, probated 8/27/1632, Herefordshire, England. 4 Tyler, P. 370-1. Sir Richard Anderson left 40 shillings to "my cousin Lawrence Washington of Brasenose." In the year of 1625, two of his sons, Henry and Robert, were attending Pembroke College. Sir Richard was lord of the manor of Pendley, which is partly within the Parish of Tring, Co. of Hereford, and his wife was Mary, a dau. of Robert, Lord Spencer, Baron of Wormleighton, and owner of the manor of Althorp. Lawrence Washington was progenitor of George Washington, whose forebearers migrated to Westmoreland Co., Va. Robert Anderson named a son, Richard. Also, his son, Matthew, was Justice of the Peace of Nork Co. in 1782.

ANDERSON, Robert, son of Richard, Jr., was b. ca 1640, d. 1712, m. Cecelia, believed to be the dau. of David Massie and his wife, Lucelia Poindexter. Historical Southern Families by Boddie, Vol. XV, p. 202: "The Andersons and Massies were in New Kent Coat the same time. "Began at James City the 10th day of November 1688. These following orders of publique charge and levy were

made in New Kent County to Cornelius Daubney, Stephen Tarlton, Robert Anderson, John Fleming, Peter Massie, and Moses Davis, Jurors, 2721 tobacco lbs.'" (Journal of House of Burgesses of Virginia 1659,1660-1693, p. 180). The Land Office, Deed Bk 7, p. 272, shows a deed granting 727 acres in New Kent Co., Va. for importation of 15 persons, to Robert Anderson. The parish book of New Kent Co. shows that he was a vestryman at St. Peter's Church from 11/1686 until parish of St. Paul was formed in 1704, in which latter place he remained a vestryman until time of his death, in 1712, aged 72 yrs. Issue of Robert and Cecelia: Richard, David, Matthew, Robert, John, Thomas, Nelson, Mary and Cecelia.

ANDERSON, Robert, Capt., son of Richard. Vestry Book and Register of St. Peters Parish, New Kent and James City Co.'s, 1684-1786, by C. G. Chamberlayne, p. 104-6: "At a meeting of captain Richard Littlepage, Captain John Scott, John Lightfoot, Esquire, and Mr. Thomas Butts, Gentlemen, in trust for St. Peters Parish and Mr. David Crawford, Major Nicholas Merriwether, Mr. Henry Childes, Captain Robert Anderson, and Mr. John Mask, Gentlemen, in trust for St. Paul's Parish, in ye Brick Church in St. Peters Parish ye 29th August 1704...To Captain Robert Anderson - 045...."

ANDERSON, Robert, Jr. b. ca 1663 New Kent Co., Va., d. 1716, aged ca 53 years. 10/23/1690 he took over the 727 acres of land in New Kent Co., Va. which had been relinquished by his father. On the same date, he received 1200 acres for the importation of persons. In 1702 he appeared as Robert, Jr., vestryman of St. Peter's Parish, New Kent Co., Va. In 1704, on the formation of St. Paul's Parish in New Kent Co. (Hanover Co. after 1720), he appeared as "Capt. Robert Anderson" and his father as Anderson, Sr. Robert, Jr. was Justice in New Kent Co. in 1714. Robert, Jr. m. Mary Overton. She was b. 6/28/1673, the dau. of William Overton who was b. England 12/3/1638 and m. Elizabeth Waters on 11/24/1670, dau. of Samuel and Ann Waters of London. This marriage of William Overton and Elizabeth Waters is proved by the LWT of Ann Waters, widow, of Parish of St. Sepulchre in London, dtd 9/29/1697, and probated 7/1700, by her son, Thomas Waters, stating..."I give unto my dau., Elizabeth Overton, now in Virginia, the sum of ten shillings, and to my son-in-law, William Overton, her husband, ten shillings.... " A patent was issued (with Eban Jones) 4/23/1681 for 4600 acres in New Kent Co., southside of Pamunkey River on Falling Creek transportation of 93 persons. Among headrights were William and Elizabeth Overton. On 10/28/1690, William Overton and John Lyddall patented 837 acres in St. Peter's Parish, New Kent Co., above main form of the Pamunkey. Issue of Robert, Jr. and Mary: Richard; James; Garland; Matthew; David of Albemarle Co., Va. m. Elizabeth Mills ca 1735, the youngest child of Nicholas Mills and his wife, Ann Clopton. David d. 1791, leaving LWT; Robert; Nathaniel; Charles; John; Charity; and Sarah.

ANDERSON, Thomas, aged 18, onboard ship "Bonaventure", 1/2/1634, bound for Virginia.

ANDERSON, William also lived at Gloucester Co., Va. He patented 60 acres of land there in 1675/6. In 1685-6, William Anderson was a Member of the Assembly, Nouse of Burgesses, from York Co.

ANDERSON, William and Rachel, his wife, of 96th Dist., S. C. sell to John Pool 90 acres on Halfway Swamp, bounded by George Blake, Thomas Pike and Joseph H. Thomas 1/3/1788. Edgefield Co., S. C. Deed Book 2, p. 161-164.

ASH, John. LWT, New Hanover Co., N. C., not dtd. Heirs: Rebecca, Samuel, William, Algernon, Acourt, Rebecca, Swann, Moore, George.

ASH, John, Esq., "Embassasor to England, d. here in negotion of these affairs, John Ash, Esqu., who, with great difficulty and hazard, got away to Virginia. the government were using all possible endeavors to prevent him." (1705). N. C. State Papers, Vol. 2, p. 899. Pg 906: "...said John Ash, walking along street was assaulted by rude, drunken uncontrollable rabble....set upon Ash and used him villianously and barbarously. Ash retired at friends, where armed multitude demanded he be surrendered, and took him to a ship (Capt. Rhett) there to Jamaica, where they threatened to hang him or leave him on a deserted isle"...signed by inhabitants, Caroline, 6/26/1705.

- ASHE, John Baptiste, son of Samuel Ashe. LWT dtd 11/2/1731, probated 11/15/1734, Hanover Co., N. C. Sons: John and Samuel Swann Ashe. Other heirs: John Russell, Daniel Hendrick of S. C. On list of names of people capable, Edenton, N. C., 1731, April 3, Member of Council.
- ASHE, Samuel. N. C. State Papers, Vol. 22, p. 786, vi. 1781:..."the threat of Maj. Craig to Maj. Samuel Ashe, his young brother and some other whigs, who has been captured by Tory bands."
- ASHLEY, John, Jr. of Anson Co., N. C., planter, deeded Thomas Ward, planter, part of a grant of 400 acres to James Terrers, 4/7/1749, conveyed to sd Ashley 9/26/1749 by deed on NS of Great Pee Dee on a branch of Little River, Bafilo Bog, 200 acres. Wit: John Ashley, Charles Robinson, Jr. Anson Co., N. C. Deeds, Vol. I, 1749-1757, p. 24.
- ASHMORE, John. LWT dtd 7/7/1776, probated 1784, Williamsburgh, Virginia, "of Prince William Co." and Colony of Virginia" names bro., William Ashmore and brother, Walter Newell Ashmore.

AUSTIN, Hampton D. listed on 1900 Mecklenburg Co., N. C. Census, Charlotte., b. 1/1845, age 55, m. 35 yrs., b. N. C., parents b. N. C. Wife: Caroline b. 9/1845, age 55, had 11 children, 8 alive, b. N. C., parents b. N. C. Son: Harison D., son, b. 12/1881, age 19, single, b. N. C., parents b. N. C., occupation: Molder. (E. D. 42, line 6, sheet 12, v. 72, R. 1205 and 1206).

AUSTIN, Hannah, wife of John, d. before 2/1784, Lunenburg Co., Va. when a cert. to settle her est. was granted Joseph Austin, Benjamin Sankford and Joseph Morton. Her maiden name may have been Hannah Love (not verified).

AUSTIN, John b. 1680-1700, first appears in 1740 Brunswick Co., Va. records, on a list of tithables, Order Bk 1, p. 345. In 1749 he was constable of Lunenburg Co., Va., owning at least 1000 acres in the pt of Lunenburg Co. which later became Halifax and Pittsylvania Co.'s. Nis LWT dtd 9/1758, probated 2/5/1760, Lunenburg Co., Va., WB 1, p. 308, of Cornwall Parish, names wife, Nannah and sons: John, Valentine, Stephen, Richardson (also called Richard), and Joseph, mentioning that the first two were then married. Issue: John, Jr.; Valentine, bequeathed 400 acres on Leatherwood Creek, then in Halifax Co., Va., now Henry Co.; Stephen, recd 370 acres on Sandy River, Halifax Co., now Pittsylvania Co., Va. from father's est.; Richard, one of father's exrs, removed to Ga. before 1779; Joseph, b. ca 1730/35, d. ca 1810 Pittsylvania Co., Va. when last taxed m. Wealthy Prewett (Pruit) 11/28/1777, in Pittsylvania Co., Va., the dau. of Daniel Pruit whose LWT 5/1755 was witd by John Austin, Sr. and Jr.. 4/1811, Wealthy Austin, his widow, was gtd L/A on his est. Joseph Austin's family lived on Sandy River in Pittsylvania Co., not far from N. C. border.

AUSTIN, John, Jr. b. ca 1720 m. before 1758 Lunenburg Co., Va.

AUSTIN, Joseph, son of John, b. ca 1730/35 d. ca 1810 Pittsylvania Co., Va. m. Wealthy Prewett (Pruit) in Pittsylvania Co., Va. 11/26/1777, dau. of Daniel Pruit.

AUSTIN, Sanford C. marriage licence in Mecklenburg Co., N. C., age 21, and Dina Hargett, dau. of Brown Hargett, marr. performed 7/19/1898 at res. of bride's father in Sharon township.

AUSTIN, Stephen, son of John, recd 370 acres on Sandy River, then in Halifax Co., now Pittsylvania Co., Va. from his father'e est. Presumed to have a dau., Mary, who m. Jonathan Davis in Caswell Co., N. C., bond dtd 4/17/1781.

AUSTIN, Valentine, son of John, made his LWT 1758. His father bequeathed him 400 acres on Leatherwood Creek, then in Halifax Co., Va., now in Henry Co., Va. Listed 1790 Census of Beaverdam Dist., Granville Co., N. C., and pd taxes in Beaverdam Dist. in 1788.
