The house was being built, when, on Good Friday, 3/22/1622, the famous indian massacre occurred which took the lives of many of the settlers living in that part of Va. Capt. Basse escaped, because he was in England at the time. The Census of 1623/4 showed residing at "Warrick Squake" and "Basse's Choice" 53 persons, including Nathaniel and Samuel Basse. Capt. Basse represented his plantation in the House of Burgesses in 1623 and 1629; was a Member of the Council in 1630 and 1631. The last reference of his is going to New England in 1631 to obtain settlers for his and

others plantations in Va. Nathaniel Basse, gentleman, was associated with Capt. Christopher Lawne, Sir Richard Worsley (Knight and Baronet) and others in establishing in 1619 the first settlement in Isle of Wight Co., Va., known as the Isle of Wight Plantation. Later, Capt. Basse, Arthur Swain and others undertook to establish another plantation in the same neighborhoos and received on 11/21/1621, a patent for 300 acres on westside of Pagen River and east of Bennett's "Wanascoyack" plantation. Issue: Nathaniel Basse, b. 1587, baptised 12/29/1589 at Church of St. Gabriel, Fenchurch Street, London, England.

He was first in Orange Co., N. C. The Court Minutes Orange Co. show the inv. of Est. of Anthony Williams was presented to Court in 1752 by Joab Brooks. Joab recd a Land Grant in Balden Co., N. C. (now Cumberland Co.) in 1756/1757. 10/1758 Joab Brooks of Orange Co., N. C. sold to William Lomax of Cumberland Co., N. C. "land which the said Joab Brooks received by a cerrtain letter patent dated A. D. 1757." In 1761 Brooks was granted 375 acres in Orange Co. on waters of Ephraim's Creek. It was on this land that he lived, and it was included in Chatham Co. which was formed from Orange Co. All land grants totaled more than 100 acres. In 1757 Joab was apptd Magistrate of Orange Co.; in 1758 he was a Member of the Governing Body. In 1761 he refused to qualify as a member of the Court. Down through the generations has been handed down a chest known as the "Sea Chest" and it is said to have been brought from England by Susan. On the side of the chest in original lettering is "S. B. -1735." From 1743-1751 John Brooks was apptd J. P. for Bladen Co., N. C.; Vestryman for St. David's Parish in 1754 for upper pt of Bladen known as Cumberland. Cumberland Co., N. C. Deed dtd 10/1/1756, John Brooks of Cumberland Co. sold to Edward Dunsfield land which had been patented to him 9/10/1735, abt 10 miles from Rock Fish Creek. All his land grants totalled about 1500 acres. He settled on SS of Tick Creek, abt 3 miles E of Ore Hill, N. C. His sons, Joab and Mark, settled on the headwaters of Ephraim Creek, abt 2 miles NW of Ore Nill. His son, Thomas, settled on the SS of Rocky River, near the Hugh Dixon Mill.
