CANNON, John was the first Cannon to receive a land grant in N.C. in 1681, Chowan Co. next to John Taylor, on southside of easternmost branch of Mattacomack Creek. Wife, Elizabeth, married after his death, William Watters. 7/7/1702, Beaufort Co., N.C., Deed Bk 1, Edward Hogg of Pamlico, Bath Co. makes a deed of gift to Elizabeth Cannon, aged under 11, dau. of Elizabeth Cannon, widow, one heifer, and to Sarah Cannon, aged under 12, dau. of Elizabeth Cannon, widow, one heifer, acknowledged July Court, at house of William Barrow.

CANNON, William was granted land in Carteret Co., N. C. in 1741.

CARMICHAEL, Duncan b. 1755, d. 7/3/1834 Stokes Co., N. C. Rev. War Soldier, drew pension. Court Minutes of Stokes Co., N. C. (1832-6), 12/9/1834, the court makes findings that Rev. pensioner, Duncan Carmichael, d. 7/3/1834, and determines his heirs at law and names special guardian for them: Richard, Lemuel, Mary, William, John, Sarah, Mina and Solomon Carmichael. Duncan Carmichael listed on 1790 Census, Caswell Co., N. C.; 1800 Caswell Co., N. C.; and 1820 Stokes Co., N. C. Census.

CARSLEY. Henry b. ca 1600 came to Va. in 1621. Original Lists of Persons of Quality 1600-1700, Henrie Carsley, age 23, from Mr. Danniell Goodkines Muster, ship "Flyinge Harte". At the age of 25 when the Muster was taken (1624/1625), he was living at Newport News, as one of Daniel Gookin's men. The shipping and cattle breeding enterprise of Goodkin did not prosper, and Henry Carsley migrated to the eastern shore where many settlers began to take up land after the 1622 indian massacre in Va. In 1633. petitioned the court held at Accomack, for a lease of 50 acres of land upon Old Plantation Creek on southside of Fishing Creek. He had previously m. Elizabeth Berriman, stepdau, of Henry Wilson of his wife, Alice, whose LWT recorded 1640 Accomack mentions her "granddau., Frances Carsley." 11/26/1635 Co., Va. Elizabeth Carsley of Accomack, exr. of husband, Henry, made Deed of Gift to her two daus. and named her stepfather, overser. Issue: Agnes; Frances b. Va. bef 1635, m. 1650 Jeffrey Minshall who gave deposition in Northampton Co. 1655, age 34. Jeffrey Minsha'll was b. Wistaston, Chester Co., England, son of Richard, and came to Va. before 1645 and by 12/17/1660 his wife and five children had gone to Maryland, where, on that date, he was assigned 400 acres known as "Adventure", lying at head of Morumscoe. He d. 4/8/1675, Somerset Co., Maryland, buried at Issue of Frances Carsley and Jeffrey Minshall: Morumscoe. Jeffrey; Randolph; Mary; Jane; Elizabeth (b. 11/23/1660); Anne m. 1685 John Moore; Alice; Thomas, b. 5/2/1671. See Minshall.

CLEVELAND, Alexander b. England before 1620, may have remained in England, but it is generally believed by his descendants that he came to America and settled in or near Prince William Co., Va. Issue: Alexander b. ca 1659 in England or Virginia. Oliver Cleveland of Spring Valley, Albemarle Co., Va., in a letter to llon. p. 39 and 176: "Ordered that summons be issued for William Collins of Essex, and George Collins of King and Queen cause them to appear at the next court held for this co Co. cause them to appear at the next court held for this county to declare whether or not they will execute the LWT of Joseph Collins, decd, 5/3/1748." In 1741, John Robertson transferred 400 acres to Joseph Collins (presumably son of Joseph), and 1744, 200 acres to William Collins. These transfers are all to son-in-law Collins and his children. William Collins transferred his to James Haley whose wife was then Beliah and presumably William Collins. James Haley is shown as having wife, ο£ Susannah (believed to be Brockman) in 1749 when he transferred \$26 acres in Orange Co. to Samuel Brockman. Susannah Collins would have been about the right age to be the dau. of Zachary Lewis I. 1/6/1768 Susannah Collins signed over her interest in her personal est. to her children, having already signed over her real estate to her children prior to 11/13/1760, at which time William, Thomas and Lewis sold to their brother, John, all the interest which they expected to have in the real estate of their father, Joseph, upon the death of their mother, Susannah. This deed was witnessed by Lewis, Sr. and Jr. and Waller Lewis, et al.
