DICKSON, Thomas migrated from Prince George Co., Va. into Lunenburg Co., Va. by 9/4/1746 when he purchased 335 acres on Lunenburg-Brunswick line. Thomas recd a grant of 536 acres, probably in 1746, which adj. a later grant of 104 acres dtd 4/1748. When Thomas settled in Lunenburg, his family consisted of his wife, Mary and children: Benjamin, Sarah, Mary, and Elizabeth. Later, another dau. was born, Ann. His LWT dtd 1763

indicated that his dau., Sarah, m. William Redmon, and the daus: Elizabeth and Ann were single. His dau. Mary m. Michael Dickson, and his LWT infers that Mary was decd by 1763. Issue: Benjamin who acquired lands in Lunenburg and Halifax Co.'s, Va. Years after his father had settled in Lunenburg, he was granted by patent 400 acres in Lunenburg for having imported a family of six persons to dwell in Colony of Virginia.

Flowerdieu Hundred was later sold by the heirs of Capt. John Taylor to Joshua Poythress. John Duke, John Taylor Duke and Henry Duke were witnesses to their mother's deed for her portion of the estate, yet remains in the possession of Joshua Poythress' descendants. Capt. Henry Duke d. 1/1718. Issue: John b. ca 1699, Capt. of Va. Militia; John Taylor; Henry of Brunswick and Lunenburg Co.'s Va. in 1742 and 1749 m. Elizabeth; William of Brunswick Co., Va. in 1733 m. DUKES, John Taylor, Sr., son of Capt. Henry, was b. ca 1715 m. Jane. Several deeds in Brunswick Co., Va. Their home lay in that part of the co. which later became Lunenburg Co. in 1745, then Mecklenburgh in 1764 where they were residents in 1769. Historical Southern Families by Boddie states that both John Taylor Dukes and his son were granted lands in Georgia for services during the Revolutionary War.

DUKES, William of Martin Brandon in Charles City Co., Va. 3/2/1672 when the Viriginia Council ordered him to take possession of the fruit belonging to the London Merchants then at the old house at Martin Brandon. DUNN, Thomas b. 1606, probably England, came to James City Co., Va. in 1620, as a 14-year old servant of Sir George Yeardley, Knight and Governor and Capt. General of Virginia. In 1623 Thomas was on the Muster of persons living at Flower Dieu Hundred, on the southside of James River, being part of the Weyanoke Plantation, the home of Governor Yeardley, situated on the border of Charles City Co., later Surry Co., Va. In his LWT dtd 1683, a Robert Burgess (wife Ann), left his land to Thomas Dunn, son of John Dunn, Sr. of Surry Co. In a deed dtd 3/4/1700 Thomas Dunn of Martin's Brandon Parish in Charles City Co., Va., Planter, sold this same land given to him by Burgess. Issue: John d. 1701 Norfolk Co., Va. m. Annie; Thomas b. 1669 d. 1772 Surry Co., Va. m. Elizabeth Gray who d. Sussex Co. 1767; William, Sr. b. Charles City Co., Va. ca 1665 m. Miss Alice Gray.

DUNN, Waters, son of William, Jr., was b. 1725 in South Farnham Essex Co., Va., a Quaker. His first wife was Sarah, dau. of William Gatewood, the mother of William Dunn. His second wife was Ann, believed to be a Fargeson. Waters Dunn had conflict with his father over certain debts which Waters Dunn owed. Before removing from Essex Co., he had an auction at which his father purchased 3 slaves. In his LWT, his father "lends" these slaves to Waters until Waters pays certain debts. About 1760 a group of families, led by Waters Dunn, migrated from Essex Co. to Halifax Co., Va., then to Pittsylvania and Henry Counties, Va. James and John, sons of Waters Dunn's brother, William, went and Frazier Gatewood. In 1765 Waters Dunn bought 405 acres in Pittsylvania Co. He appears to have accumulated several hundred and even though residing in Henry Co., he still sold land back in S. Farnham Parish, down to 1779. Also, his LWT, in Columbia Co., Ga., speaks of "the remainder of my estate lying in part whatsoever", implying that he still owned land in Virginia. He came to Georgia ca 1780, and d. Columbia Co. 1803. His first wife, Sarah Gatewood, probably d. Henry Co., Va. Issue of Waters and Sarah: William m. Anne Thompson 12/18/1788 Greene Co., Ga.; Richard b. Essex Co., Va. DUNN, William, Sr., son of Thomas, was b. Charles City Co., Va. ca 1665 m. Alice Gray. Most likely she is descended from the Grays who were left as servants of Governor Yeardley, along with Thomas Dunn. William's brother, Thomas, of Essex Co., m. Elizabeth Gray. William settled in the frontier parish of South Farnham in Essex Co. ca 1688. He accumulated several hundred in Essex Co. in 1699 for bringing nine persons into the Colony, and apparently William inherited it or was given this land. Died 1732. In his LWT he left his three youngest sons 500 in Caroline Co., Va. and a gift of 100 acres to John Williamson. His personal estate was equally divided among his six youngest children. Issue: Henry Eaddy 5/2/1778-9/10/1855 m. Martha Stone b. 2/18/1774 and had issue: Thomas Eaddy b. ca 1801 d. 4/4/1862 m.
