

MACKAY, Ann, Mrs., relict of late Dr. John, d. at Beaufort, S. C. 12/19/1807, age 63. The Charleston Times dtd 11/9/1809.

MACKAY, James and Martha, his wife, William Stewart and wife, Ann, John Cattell, son, and heir of Sarah Cattell, all of Charleston to Daniel Howard of Granville Co. for #2840, int. on est. of 1420 acres. Whereas, Lt. Gov. Thomas Broughton granted Henry Peronneau and James Osmund as surviving exrs of LWT of Col. Arthur Hall for use of Robert and Christopher Hall, infant, on 8/7/1735, 1420 acres in Granville Co. and Robert and Christopher Hall d. in infancy and Elizabeth (wife of Henry Perroneau) and Martha (wife of James Mackay), and Ann (wife of William Stewart) and John Cattell were co-heirs with Christopher and James Osmund, joint granted, is dead; so that the trust survived Henry Perroneau; now he, with others, sells to Daniel Howard.

MACKAY, John, mariner, of Charleston deeded from George Lea and wife, Elizabeth 5/1/1744, Lot 18 ES of Union St.; whereas, George Lea, shipwright, by LWT dtd 11/22/1739 left his son, George Lea and dau., Elizabeth Lea, and dau., Lydia Lea. Should Lydie die before age 16, her share to go to George and Elizabeth (now wife of John Mackay). S. C. Deed Bk Z, p. 512.

MACKAY, Patrick and Isabella of Granville Co. on 9/15/1762 deed to Joseph Nutt for 4400#, land in St. Peters Parish, Granville Co., S. C., Savannah River. S. C. Deed Bk B-3, p. 766. Also, Patrick Mackay of Granville Co. on 9/8/1739 deeds to Samuel Montaigt and Charles Parry for 2457#, N. branch of Savannah River on Back River, 800 and 360 acres in Granville Co. S. C. Deed Bk T, p. 217.

MACKAY, Sarah, Mrs., widow of Dr. James Mackay of Waccamaw, d. 10/26/1809, age 62. The Charleston Times dtd 11/9/1809.

MADISON, John, "To Mr. John Madison, Augusta, 11/2/1758...Dear Sir: I wrote you last night by Mr. McMahon..." /s/ James Madison. Records of Augusta County, Virginia 1745-1800 by Chalkley, p. 517.

MADISON, John, father of John and Ambrose Madison. (1) Ambrose m. 8/34/1721 Frances Taylor, dau. of Colonel James Taylor and Nartha Thompson. Frances was b. 3/30/1700-d. 10/25/1761. Ambrose d. 1732 Spotsylvania Co., Va., his LWT dtd 7/31/1732, probated 2/10/1733, St. Marks Parish, Spotsylvania Co. names his brother, John, dau., Elizabeth, and a son, James. 7/4/1727 deed from Major Augustine Smith of Spotsylvania Co., Va. to Ambrose Madison of King and Queen Co., Va. Issue of Ambrose: Elizabeth; James b. 3/23/1723 m. Nelly Conway 9/15/1749 (had son, Pres. James Madison 3/16/1751-6/28/1836 m. 1794 Dorothy Payne Todd, widow, his LWT dtd 1835

Orange Co., Va. names niece, Nelly C. Willis and Nelly Baldwin. Nephews, Robert L. Madison and Ambrose Madison. Bro-in-law: John C. Payne. Stepson: John Payne Todd). Other children of James Madison, Sr.: William (1762-1843); Ambrose (1755-1793); Francis (b. 1753) and Reuben (1771-1775). (2) John d. 1783 Botetourt Co., Va., but did not name all his sons in his LWT. There was a lawsuit of Aug. Term 1800, Augusta Co., Va. from the other heirs. Issue: William m. MADISON, Priscilla, the devisee of Richard Madison, and William Bowyer, admr. of Est. of Richard Madison vs. Thomas Madison, Agatha Madison, et al, exrs of Est. of John Madison. 8/22/1786. August Term of Court, Minutes of Augusta Co., Va. Priscilla Madison was the dau. of William Bowyer. Records of Augusta County, Virginia 1745-1800 by Chalkley.

MADISON, Richard, his LWT dtd 10/16/1676, probated 1/9/1677 Isle of Wight Co., Va. names dau., Elizabeth, wife of John Waugh. Wife: Ann.

MADISON, Richard d. 2/23/1785. Wife: Priscilla. No issue. His eldest bro: Thomas Madison, decd. Records of Augusta County, Virginia 1745-1800 by Chalkley.

MALONE, Anderson m. Susannah Malone 12/16/1816 Mecklenburg Co., Va.

MALONE, Daniel, son of Nathaniel, was b. 9/15/1733, baptised 6/17/1733 Bristol Parish Register, Prince Edward Co., Va. He witt the LWT of his bro., Drury Malone, dtd 1787 in Mecklenburg Co., Va. His LWT dtd 11/3/1795 Halifax Co., Va. names daus: Mary Irvine, Elizabeth Trnum, Becky Andrews. Sons: Thomas, Nathaniel, Drury, John, Jameson and Banister. Drury m. 7/24/1799 Prince Edward Co., Va., Nancy, dau. of William North, removed to Greene Co., Ga.; John, d. Greene Co., Ga. 1816, one of purchasers of Est. of Reuben Trnum, Patsy Malone, admx. Wife, Patsy, married again, Arthur Lovins, according to division of estate 12/30/1820 in Greene Co., Ga. Orphans of John Malone, tuition pd by Arthur Lovings 6/1824 Greene Co. (Returns and Divisions) for children: John, Thompson, Clement and Arthur. Thomas Malone m. Susannah Tuck 7/22/1785 Halifax Co., Va.

MALONE, Daniel, son of Nathaniel, was b. ca 1690 Prince Edward Co., Va. m. 1717 Mary and had: William b. 1718 Sussex Co., Va.; Mary b. 1719 Sussex Co., Va. His father, Nathaniel Malone m. Mary

Wynne and had: William d. 1745 Sussex Co., Va., his LWT dtd 1745 m. 1714 Ann Robinson; Thomas m. Mildred Chappell; Daniel (above); Nathaniel; Drury; Amey. Our Ancestors by Alberta Malone (1953),

MALONE, Daniel was b. 1643. Res. of Charles City Co., Va. in 1664-1665, per deposition dtd 2/1/1665: "The deposition of Daniell Maloone, aged 22 years or thereabouts, swore...that Welthan Taylour late servant to Daniell Nunelly spoke to this deponent about two or three and twentyth of December last past to draw a condition betwixt herselfe and Daniell Nunnely...." Wit: Robert Wynne. Charles City Co. Court Orders 1664-1665, p. 628. He apparently removed to Prince Geo. Co., Va. as in 1704 he was listed on the Quit Rent Rolls as a land owner of 100 acres. 10/31/1715 Daniel Malone recd a land grant in Prince Edward Co., Va. of 99 acres. Issue: Nathaniel b. ca 1670/1680 m. Mary Wynne, dau. of Thomas and Agnes Wynne of Prince Edward Co., Va., whose grandparents were Robert Wynne and Mary Poythress, the widow of Francis Poythress of Prince Edward Co., Va. MALONE, Luke in Dover in 1670 m. 11/20/1677 Hannah Clifford, perhaps the dau. of John. Issue: Sarah b. 1679; Joseph; Samuel; Luke; Elizabeth and Nathaniel. Genealogical Guide to the Early Settlers of America p. 346.

MALONE, Nathaniel, his LWT 5/5/1779 Greensville Co., Va. Will Bk 1781-1806, p. 1. "Nathaniel Malone of Brunswick Co., Va." names wife, Sarah. Dau: Polly. Son, Thomas, when he comes of age. Bros: William, Mial and, Daniel Malone exrs with Peter Wyche.

MALONE, Robert, his LWT dtd 1779 Northampton Co., N. C. names Thomas.

MALONE, Thomas b. ca 1700 Prince Edward Co., Va., son of Nathaniel, m. Mildred Chappell, removed to N. C. Issue: Isham removed to Granville Co., N. C. where he died, leave LWT dtd 1775. There is a record of a marriage of Isham Malone to Elizabeth Hamlin, dau. of William Hamlin 2/4/1769 in Amelia Co., Va. Issue of Isham: (1) George d. 1818 Jasper Co., Ga., lived Caswell Co., N. MALONE, Wood, his LWT dtd 1774 Warren Co., N. C. names William T. and Barsheba.

MAN, Arnold first appears in 1696/7 in King William Co., Va. as a planter with Mary, his wife. He was a witness in 1704 King William Co. to the LWT of George Chapman. Ref: Page 280, History of Southern Families, IX, by Boddie.

MANN, John recd land grant in Craven Co., S. C. 550 avres, 8/17/1750. S. C. Land Grants, Vol. 7, p. 525.

MANN, John was exr of LWT of John Ouldfield, Craven Co., S. C. dtd 3/27/1751, probated 12/30/1752.

MANN, John Michl recd 50 acres on Colliers Creek. S. C. Land Grants, Vol. 5, p. 248, dtd 8/10/1734. Also, 50 acres on Colliers Creek, Vol. 5, p. 145, dtd 4/6/1753.

MANN, Miles. First Settlers of S. C. 1670-80 by Agnes Leland Baldwin: "Man, Miles - Overseer on Lord Ashley's Plantation (c. 1/1671/72)." The Shafesbury Papers and other records relating to Carolina and the first settlement on the Ashley River prior to 1676 are given in part, from Vol. 5, of the S. C. Historical Magazine. Miles Mann was from London and traveled to Carolina with various letters, in attempts to settle him as co-manager of Lord Ashley's plantations. There is a notation in Vol. 5, p. 375: "Miles Man returned to England June 1673."

MANN, Newby of 96th Dist., S. C. granted Richard Tutt of same place 1/16/1778 100 acres on waters of Cuffeetown Creek (on N side) in Granville Co. bounded SW by William Rowan, NE by Thomas Wallace, S by Nuby Mann. Wit: John Hagwood, John Mills, Alexander Mills.

MANN, Robert, "At a Court holden for Accomack Co. 11 Jan 1640 Robert Mann was mentioned in a Certificate granted to Col. Obedience Robins for 2000 acres for the transportation of 40 persons (including Robert Mann). Ref: Land Certificates for Northampton Co. (Virginia)

MANN, Robert mentioned as Head of Family in Henrico Co., Va. in 1679. Ref: 24 William & Mary (1), p. 132.

MANN, Robert lived and died in vicinity of Newberry, S. C. His LWT dtd 1782 named three sons, James, John and Robert. His son, John, had four sons, Henry, Robert, Joseph and James. James Mann, son of first mentioned Robert Mann and wife, Judith Mann, lived in S. C. until latter part of 17th century. He was in the Rev. War in 1775, removed to Elbert Co., Ga. and lived near Ruckersville on the Savannah River. Their children were: John b. 10/7/1767, d. 1841; Joel b. 9/23/1769; Jessie b. 8/5/1771; James, Jr. b. 9/12/1773 m. Esther Lewis 4/7/1822; Jeremiah b. 6/10/1775; Martha b. 6/1779; Elizabeth b. 11/20/1782; Asa b. 3/14/1785; Henry b. 2/14/1786. John, oldest son of James, m. Sara Ann Harper and removed to Monroe Co., Ga., bur. old family cemetery near his home. His children were: Morsham b. 9/1/1793; Jolly b. 1796; John J. b. 1/13/1797; Stephen b. 2/22/1799; Frances b. 3/16/1801; Sallie K. b. 2/14/1803; Thomas b. 11/15/1804; Asa b. 3/8/1809. MANN, Robert recd 350 acres in Berkeley Co., S. C. 2/15/1763. S. C. Land Grants, Vol. 17, p. 555. Also, 350 acres in same co., 9/1/1768, Vol. 17, p. 545.

MANN, Robert, his LWT dtd 1782 Newberry Co., S. C. names James, John and Robert. John and Robert, Jr. lived and died in Newberry Dist. James, a Rev. War Soldier, d. Elbert Co., Ga., near Ruckersville. (Issue: John 1767-1841; Joel b. 1769; Jesse b. 1771; James, Jr. b. 1773; Jeremiah b. 1775; Martha b. 1779; Elizabeth b. 1782; Asa b. 1785, Henry b. 1786).

MANN, Susannah recd land grant in Craven Co., S. C., 400 acres 6/21/17--, S. C. Land Grants, Vol. 11, p. 337. Also, 400 acres in Craven Co. 7/13/1770, Vol. 19, p. 548.

MANN, Susannah, Mrs. Estate issued 5/6/1785 for use of the Militia and Garrison of George Town in 1781 and 1782. Vol. II, Box O-Q, S. C. Stub Entries by Salley.

MANN, Thomas, his LWT dtd 9/30/1735, probated 11/1735 Bertie Co., N. C. Heirs: John, my plantation and 640 acres; Thomas, plantation on Wickacone Creek. Cousin: William Crawman, land on Killam Swamp. Dau: Mary. Grson: George Williams. Wife: Bridget. Exrs: George Williams, Sr., Thomas Busbey. Wit: Charles Horne, George Williams, Jr.

MANN, Thomas, planter deeded to his sister, Sarah Mann, wife of Francis Davis, 100 acres on Corowaugh Swamp. 9/13/1694 he sold to James Curley 150 acres on the NS of same swamp, adjacent to sd Thomas Mann's line, James Johnson and Charles Mann's old field. Isle of Wight Co., Va.

MANN, Thomas in 1692 discovered an illegal flaw in the assignment which Richard Booth had made his father, Thomas Mann, on 11/8/1681, for that year he went to court and brought action against Richard Booth to make a "good and sufficient" deed of sale for the land to him Thomas Mann, Jr., heir of Thomas Mann, Sr., deceased. (Another deeded dtd 2/9/1692/3 was mde). 11/8/1696 Thomas Mann sold the remainder of this land, then 200 acres, to Nicholas Tyler, as "Thomas Mann, Jr. and heir of Thomas Mann, late of Isle of Wight Co., deceased". Isle of Wight Co., Va. Deeds.

MANN, Thomas, Capt., son of Miles Mann, was b. ca 1670 in England, a res. of Charleston, S. C. Wills and Misc. Records, Charleston Co., S. C. 1694-1704, p. 30: "Received from onboard the ship Edward & Francis, Capt. Thomas Mann, Commander, sundry merchandise...of Mr. John Vobe, Merchant in London...." Recorded 9/29/1695. P. 245: "Know all men by these presents that I, Thomas Mann, of the City of London and Kingdom of England, but now in the said Province, Mariner, am held and firmly bound unto Micajah Perry, Richard Haynes & Co. of London, Merchants...." 7/4/1700. South Carolina Genealogical Magazine, Vol. VIII, p. 167: (Abstracts from Records of Court of Ordinary of S. C. 1692-1700 by A. S. Salley. 6/3/1698-99, Capt. Thomas Mann, on behalf of

himself and brother, entered caveat to the Estate of Joseph Rider, decd, and prayed for Ltrs of Admn. Same magazine, Vol. XI, p. 123: 3/15/1698-1699, Thomas Mann, Edward Loughton and Samuel Ward executed their bond to Gov. Blake for Mann's faithful admn. of est. of Joseph Rider. (p. 357-8) Thomas Mann recd from Thomas Hall 200 acres in Berkeley Co., S. C. 5/4/1699. S. C. Land Grant Book N. C., p. 219. The St. Andrews Parish Register gives the burial date of Thomas Mann, Sr. - 9/29/1736. He wtd the LWT of Mary Bassnett, widow, dtd 3/21/1721/2, probated 4/13/1722, along with "Anne Mann, Jr." Issue: John of Berkeley Co., S. C. Register of St. Andrews Parish 1719-1774, p. 83-87, S. C. Historical and Genealogical Magazine, Vol. 14, names his children, viz: Anne (dau. of John and Anne) b. 8/11/1745, buried 8/19/1745; Catherine (dau. of John and Anne) buried 2/10/1745; Robert b. 11/26/1747; Richard, son of John and Anne, baptised 10/6/1746, buried 12/2/1746; Robert (son of John and Anne), baptised 11/29/1748; Elizabeth (dau. of John and Martha) b. 2/5/1750; Elizabeth (dau. of John and Martha) baptised 2/19/1750; Beulah (dau. of John and Martha) b. 6/14/1752; Beulah (dau. of John and Martha) baptised 6/17/1753; Thomas (son of John and Anne) baptised 2/19/1742, buried 12/27/1762. MANSELL, William, his LWT dtd 4/9/1739, probated 5/6/1740 Charles Co., Md. names son, Benjamin Clark, alias Mansell to be left in care of Richard Davis for 3 yrs. schooling and at age 15 to be bound out as a carpenter until age 18. Exr: Richard Davis.

MARRIOT, Nathaniel 1/26/1721 deeded Ralph Mason of Chowan Precinct 50 acres on SS of Morattock River. Chowan Co., N. C.
