RAIFORD, Matthew, Sr. was member of House of Assembly, Anson Co., N. C., J. P.; land owner in Craven Co. in 1746.

RAIFORD, Matthew, Sr. (1687-1758) m. Mourning Matthews. (Daughters of American Colonists, Ancestor Index p. 320, 1976), his LWT dtd 1752 Bladen Co., N. C., son of Col. Philip Raiford I, m. Mourning. Application dtd 7/18/1931. Catalogue of Noble Families and their Coats of Arms of Brittany, Vol. 3, p. 24 states that Raifords came from France (Brittany). Allan, father of Jean Ravart, d. before 1479. Lord Ravart of LeMarre Parish near Lambelle. Name changed from Ravart as families journeyed through France, England, Scotland by the Bermudas, finally to Virginia Colony. Rabart - Raisford - Rainsford - Rayford and finally, Raiford.

ROSS, John, son of John, b. ca 1700, d. 1764 Kent Co., Delaware. Admn. of his Estate, Kent Co. gave John Parker and his wife, Elizabeth, the late Elizabeth Ross, bequests 5/24/1764; also to Margaret, his dau., who later m. William Wallace; and to his son, William Ross.

ROSS, John, son of John, planter, Dorchester Co., Md., his LWT dtd 1/21/1722, probated 5/25/1723, named children: John Ross, Priscilla Ross, Sarah Ross.

He removed to Hancock Co., Ga. ca 1795, listed in Jackson Co., Ga. Tax Records of 1802, later on 1820 Wilkinson Co., Ga. Census.
