The four sons received personal estates, and the children were to select their own guardians at age 16 years in the event of the marriage of his wife." Thomas Tull, Sr. sat on the grandjury of Priscilla White and George Layfield case, where Mr. Layfield married his nicce and the courts denied the legality of the marriage because of close family ties, however, the couple did win out in the end and their marriage was made legal. This case became famous in Somerset Co., as well as a scandal. Mary Minshall was the dau. of Jeffery Minshall and his wife, Frances Carsley who were residents of Northampton Co., Va. (Northampton Records, Order Book 1651-4, p. 48), with Minshall entering his rights for land in Somerset 4/12/1662.
