

## *Hancock of North Carolina*

Acting as the attorney for Lord Pollock, **William Hancock** came to America from England about 1707 when he was granted a large tract of land now known as Hancock's Creek situated along the Neuse River below New-Bern, North Carolina. He was mentioned in the North Carolina Records as an Indian fighter, building a road (in 1722), and being one of twelve Vestry of Craven Parish in 1723. He and Cullen Pollock were commissioned in 1723 to sell the town lots of New-Bern. His Last Will and Testament is found in the Craven Precinct, dated 10/9/1722, probated 3/16/1730-1732 wherein he named his son, William. To his grandson, John Hancock, he left "my plantation". Another grandson named was William Hancock. Granddaughters: Elizabeth and Mary. Wife and executrix, Elenor.

Issue:

- William Hancock, a member of the North Carolina General Assembly in July of 1733 and 1734. His Last Will and Testament, denoting the ownership of many acres of land and slaves, was filed with the Secretary of State 1749-1753, on page 69. Issue:

- Hector Hancock resided in Carteret County, North Carolina where he died in 1752 leaving a will and naming all of his children. Wife, Ann.

Issue:

1. Nathaniel Hancock was married to Sarah Ward, the daughter of Enoch Ward of Carteret County. He was a Member of the Provincial Congress in Hillsborough, North Carolina on 8/20/1775. Resident of Onslow County where he died in 1800. Issue:

  - ii. Enoch Hancock resided in Onslow County. Issue:
    - a. William Hancock, born 10/15/1773, died 9/27/1849, married 1<sup>st</sup> Dorothy, 2d, the widow Dudley, and 3<sup>rd</sup>, Ruth Huggins, sister of Luke Huggins. He was a resident of Onslow County.

Nathaniel Hancock, born 12/29/1802 in Onslow County, died 6/19/1854 in Bossier Parish, Louisiana, married on 1/28/1824, Elizabeth Hightower (11/16/1801-3/29/1850).

Issue by 3<sup>rd</sup> marriage: Enoch, Hull, Noah, Joanna and Roxanna Hancock. Issue.
