In the Name of God Amen I Josias Jones of Beaufort County in the Province of North Carolina being sick and weak in body but of perfect sense and memory Do make and Ordain this my last Will and Testament in manner and form following Inprimis I Recommend my Soul Into the hands of God who gave it hoping through the merits of my Blessed Lord and Saviour Jesus Christ to Receive a free pardon for all my sins and my body to the Earth to be Decently Buried in a Christian like manner as my Executors hereafter named shall think fit and as for what Worldly Estate it hath pleased God to bestow upon me I give and bequeath in manner and form following

Item I give and bequeath to my Daughter Sarah Dinde the land on bear Creek that William Creekmore now lives on likewise all the cattle that ^{her} mark among my Stock

Item I give to my Son Frances Jones the plantation he now dwells on together with all that Land I own on that side of the Creek runs up by his Door likewise all the household goods that is now in his possession Except my Still and the bot leaf

Item I give to my Son James Jones the old field opesett to my Son Frances with all the Land adjoining the said old field on that side of the Creek on consideration of his making his Brother David a Deed for the Land the fork of bear Creek

Item I Give my two younger Daughters Mary & Elizabeth my

Dwelling plantation on the Great Bay to be equally divided between the two

Item I give to my two Sons Josias and William Jones all the Land I own on the Deviding Creek on the South Side spamples lathly Item I give to my Son Josias Jones one featherbed an furniture with a bed tick and one Mare called Swallow likewise one buckaneer gun which is my own using gun and also my Great Church Bible Item I give to my Son William Jones one horse called Spark and one Mare bock that came of the mare I let Sias have and buckaneer gun called hummers also one Iron bound Chest now at Richnd one Iron pot holds about four gallons Item I give to my Son John Jones one hors called Speedwell and my one little gun that I use And all the Residue of my Estate goods and Chattels that are not heretofore mentioned I leave together with my money to be equally divided between my Seven youngest Children named as follows David James Mary Betty Josias William & John Jones.

And I Do hereby constitute and appoint my Dearly beloved wife Ann Jones and Francis Jones and James Jones my two sons full Executors and Executors of this my last Will and Testament utterly Revoking and Disannulling and making void all former or other Wills Testaments Legacies and Bequeaths Ratifying and Confirming this and no other to be my last Will and Testament.
