 daughter Patsy Morgan I give and bequeath  
 to my grand Daughter Margaret Ann Morgan  
 and John Bradley Morgan my grandson the above  
 property to be equally divided between them or such  
 part as may be remaining after the death of my  
 said daughter Patsy Morgan to them their heirs and  
 assigns forever.

Second I give and bequeath to my grand daughter  
 Mary Simpson one bed and furniture, one bureau,  
 one folding table, and two Windsor chairs to her her  
 heirs and assigns forever.

I do appoint and ordain my friends William  
 Johnson, Margaret Dranahan and David Lloyd  
 Executors of this my last will and Testament.
