In the Name of God "Amen"

The 21st day of May in the Year of Our Lord
1793, I James Moore of the County of Bladen and
State of North Carolina living through the abundant
mercy and goodness of God though weak in body
but of a sound and perfect understanding and
memory do constitute This my last Will and Testament
and desire it to be received by all as such and as
touching such worldly estate wherewith it hath pleased
God to bless me with in this life I give devise and do
part of in the following manner and form

I give and devise and bequeath unto my daughter
Cardice Moore the tract of land containing fifty
acres whereon I formerly lived lying on Bladensawp
with some Head of cattle marked with a stable mark
in the right ear and a Coronation fork in the left

I give to Obagile Harris during his life the plant
ation whereon I now live or Samm's Branch containing
fifty acres and after his death I give to my daughter
Cardice and her heirs forever

As for the remainder part of my property I leave the
use of it to Obagile Harris for my daughter
Cardice comes of age and then to be equally di-
vided between two all to the amount of Fifty Shillings
which I specially give to be divided between my
two daughters Lydia Moore andannah Moore
And I do likewise nominate and appoint Abramaw
Pruinaw and Obagile Harris my Executors to this
my last Will and Testament rototyping and affirming
this and no other to be my last Will and Testament

I desire may be decently interred by my
executors hereafter mentioned and as to such
worldly goods as it hath pleased god to endow
me with I give devise and bequeath in
manner and form following.

First I give and devise and bequeath unto
my above mentioned friends Elizabeth Berry and
Lure Shatto all and every part of the remainder
of my property goods chattels bonds obligations debts
and dues which may at my death appear or
be owing to be equally divided between them
their heirs and assigns forever.

I nominate constitute and appoint Michael
Jones and William Shatto Executors of this my
last Will and Testament thereby revoking all
other Wills or testaments or any such writings
made by me heretofore.
