Also fifty dollars in money. Next, I give and bequeath to my next eldest daughter Helen Evans eight hundred dollars in money. Next, I give and bequeath to my next eldest daughter Mary E. Bland eight hundred dollars in money. Next, I give to my youngest daughter Caroline Thompson eight hundred dollars in money. Next, I give to the Foreign Mission Board the interest of one hundred dollars to be paid over to said board yearly until the interest amount to one hundred dollars, then said one hundred dollars to be divided between my lawful heirs. And after my funeral expenses is paid and just debts, then balance of my property to be equally divided between my lawful heirs. And do nominate and appoint my son-in-law Daniel P. Bland

sole executor of this my last will and testament hereby revoking and making void all other wills I have heretofore made
