3<sup>rd</sup> I give and bequeath to my son Richard M. Simpson the following negroes Rachel John and Abby, and their increase during the term of his natural life then to his lawful heirs or

4<sup>th</sup> I give and bequeath to the children of my daughter Margaret Ann Russ. and her husband in case the following negroes Patty. Frank and Dennis with their increase to them and their heirs and assigns forever.

5<sup>th</sup> I give and bequeath to my son William Simpson Jasper. Becca. and Lavinia. with their increase to him his heirs and assigns forever.

6<sup>th</sup> I give and bequeath to my son Joseph Simpson Charles. Peggy. and Lucy. with their increase to him his heirs and assigns forever.

7<sup>th</sup> I give and bequeath to my daughter Cecilia Simpson Anthony. Caroline and Dianaah. with their increase to her heirs and assigns forever.

8<sup>th</sup> I give and bequeath to my son James B. Simpson Larry. Kentz. and John and Sarah and their increase to him and his heirs and assigns forever.
