RECORD OF WILLS.

In the name of God "Amen."
I, Jno. McMillan of the County of Adams being
being of sound and disposing mind memory
and understanding do make and publish this
my last Will and Testament

I give to my Wife Mary. Negroes Sapia and Soley
also my Household and Kitchen Furniture my
Sorel Horse John. One Yoke of Oxen and Cattle
and Cows during her life and at her death the
said Negroes and other Property to be equally di-
vided between my sons. Randal and Jno.

I give and devise unto my sons Randal and
Jno. the plantation upon which I now live
and situate on the River to them and their heirs
to be equally divided between them.

It is my Will and desire that my Wife Mary shall during
her life have use of the dwelling and out houses
and as much of the cleared land in said plant-
ation as she can cultivate with the privilege of
making staves and otherwise using the timber in
said plantation

I give and devise to my son Dugald my back
plantation where I formerly lived consisting of
several parcels of land to him and his heirs for
ever.

I give to my son Dugald. Negroes. Lucy, Charity
Jane Rachel and Cety. and their future increase
also my gold Watch and a Promissory note made
by the said Dugald and payable to me for
five hundred dollars. and dated the 3rd of May-
1837.

I give and devise to my son Archie the
plantation on the main road which I bought
of Cal McQuigalt. and Dugald McMillan to
him and his heirs forever.

I give to my son Archie. Negroes Callender
Sarah Callender. Miran and not. and their future
increase also my boy Mare Pat and three
Cows and Cattle.

I give to my son Randal and Jno. the
plantation upon which I now live and situate
on the River to them and their heirs

also the remainder of my property whatever
it may be consisting of. stores. Hogs. sheep
plantation tools. or other personalty.

And it is my Will that whatever debts may be
due and owing by me at my death. shall be
paid by my son Randal and Jno. and the prop-
erty hereby given them is made chargeable with the
same.

And further in case my estate shall be subjected to
the payment of debts of Dugald McMillan or of the
said Dugald and Cal McQuigalt. For which I am
security that the property given to said Dugald
shall be chargeable with the same and my
Executors herein after named are hereby fully
authorized to sell any part of the negroes or other
personal property bequeathed to Randal and Jno.
or to Dugald. should it become necessary in order
and to provide for the payment of the debts aforesaid.

I hereby nominate and appoint my sons Dugald
and Randal. Executors of this my last Will and Test-
ament.

Signed by said Jno. McMillan in presence and Subscribed
by us in his presence and the presence of each other
this 21st July 1839
