I give and bequest to each of them and their heirs forever,

Further my will and desire is if it should please god to take any of them my children out of this world before they should have lawfully born of the female or lawfully begotten by the male then their portion or legacy shall be equally divided amongst the rest of my children that shall be alive.

Thus I likewise constitute make and ordain my dear and well beloved wife Executrix and Benjamin Cooper, Executor of this my last will and Testament and I do hereby disallow revoke and disannul all and every other former Testament wills legacies or bequests and Executors by one in any way before written or bequeathed ratifying and confirming this and no other to be my last will and Testament in witness whereof I have hereunto set my hand and seal the day and year above written.

I give and recommend my soul to god that give it and my body I recommend to the earth to be buried in a decent christian burial at the discretion of my Executors, nothing doubting but at the general resurrection I shall receive the same again by the mighty spirit of God. and as touching such worldly estate which with it hath pleased god to bless me in this life. I give devise and dispose of the same in the following manner and form

First of all I give and bequest unto my well beloved wife Elizabeth my dwelling house and plantation whereon I now live during the time of her widowhood and afterwards to be equally divided between my two sons Joseph and Leonard Lock and likewise a piece of back land lying back of Thomas land. and further I give to my beloved son Thomas, one half of a piece of land lying between Wickersons Creek and Harrisons Creek, joining his own lightwood land, and the other half I give to my sons to be equally divided and likewise I give to my son Thomas one pair Steyarts the weight 154. and likewise I give to my son John a piece of a Cedar Swamp, lying on Harrisons Creek Sayamp, patented in my own name and Benjamin Lock the half of said land and likewise my will is to give my daughter Elizabeth Elmer, two Cows and Calfs. likewise as soon as it can conveniently be done they are to purchase a likely negro girl. likewise I give to my daughter Hannah, one Cow and Calf likewise in proper time at the discretion of my Executors to the rest of my daughters. Mary Eliza Anna and Rebekah, each one Cow and Calf. my will
