I give and bequeath to my grand son Joseph Satter son of William Satter all of my lands not already bequeathed to him and his heirs.

I give and bequeath to my son John Knapp the sum of five pounds which is to be paid out of my estate payable to the division of my stock between William and J. Knapp.

I bequeath the Negro girl Bet. which I have devised to my daughter Elizabeth Satter. as her part.

"Hus"

I give and bequeath to my daughter Mary Ellis wife of John Ellis. my negro woman named Bess and girl Alice to her and the heirs of her body forever.

And I hereby make and ordain my worthy friends William Roberts. and James Morhead. Executors of this my last Will and Testament.

I Matthew Kelly being of sound and perfect mind and memory Blessed be God. do this the 12th day of April in the year of Our Lord One thousand Eight hundred and Six. make and publish this my last Will and Testament in manner following that is to say.

I give and bequeath to my son Matthew Kelly his heirs and assigns One Hundred and fifty acres of land at the mill. and One hundred the old Patent ninety nine acres on the lower of the Brown Marsh beginning at a stake and a marked maple. one hundred acres on the Horse Shoe Swamp. and four negroes Martin John and Peter.

I give and bequeath to my son James Kelly his heirs and assigns One Hundred acres of land on the West side of the Brown Marsh Swamp beginning at a small gum tree, and two hundred acres on the Brown Marsh Swamp beginning at a Red Oak said Kelly. Corner, and forty three acres on the West side of the Brown Marsh Swamp. Joining John Kellys line also one hundred acres joining the same and all my horses cattle hogs. sheep and household furniture and the ferry. and four negroes Deace. Rachel East and Sol.

I give to my daughter Sarah Wingate and the heirs of her body one negro Ellick.

I give and bequeath to my daughter Etudie Kelly and the heirs of her body One hundred acres of land on the Beaver Dam. Bay. and four negroes Sam. Geo. Ann. and Anderson.

And I hereby make and ordain my worthy son Matthew Kelly. and James Kelly. Executors of this my last Will and Testament.
