John by Divine Providence Archbishop of Canterbury, Primate of all England, and Metropolitan and Archbishop in Our Lord God Endorsing and will that we doubtless faith be given by these presents, and do make known and will that it be made known to you that in searching the Registry of Our Prerogative Court of Canterbury in the Archives thereof there well and faithfully kept and preserved we have discovered and plainly found amongst other things in the same that in the Eighth day of November in the Year of Our Lord One thousand Seven hundred and Christy nine at London before the Honorable Charles Carter Doctor of Laws, Surrogate of the Right Honorable Sir William Murray, Knight Doctor of Laws, Master Keeper of the Prerogative Court of Canterbury, lawful Constituted in last Will and Testament of Gooden Borne deceased late of Mount Pleasant in the State of North Carolina in North America. having whilst living and at the time of his death, goods and Chattels or Credits diverse and of Jurisdiction sufficient to form the Jurisdiction of our Prerogative Court of Canterbury aforesaid, was proved approved and registered and administration of all and singular the goods Chattels or Credits of the said deceased or in any way concerning his said Will was granted to John Younger the sole Executor named in the said Will. in having been already sworn into and faithfully to administer the same and to make a true and perfect inventory of all and singular that said goods Chattels or Credits, and to exhibit the same with the Registry of Our said Court on or before the last day of May next ensuing and also to render a just and true account thereof which said Will follow in these words.

I Gooden Borne of Mount Pleasant near Fishing Cape Fear North Carolina. now of St. Pauls. the County of Middlesex in the Kingdom of England do this my last Will and Testament in the manner following.

"First" All my Just debts and funeral expenses paid.
 "Secondly" I give devise and bequest all my effects in America
 to Judith now on Mount Pleasant of said state, as
 aforesaid to her her heirs and assigns forever.
 "Thirdly" I give and bequest unto my natural children William
 Forbes McLean and James McLean, which I bear by the
 said Judith of the above mentioned place in North
 Carolina the sum of three hundred pounds sterling
 each, and I do hereby appoint John Younger of
 Cherrington place my whole and sole Executor to the
 my said Will. And he the said John Younger shall
 do or cause to be done that the sum of three hundred
 pounds above mentioned to be appropriated to the use
 of educating and giving trade unto them my said
 Natural children W. B. McLean and J. McLean, as aforesaid.
 And I do give unto he the said John Younger the sum
 of Two hundred pounds after this all be done.
 I leave unto my Goodwin B. Borne, all the remains
 of my property let it be of whatever nature or kind
 whatever to him heirs and assigns forever, this witness
 all after Wills made by me.

 the said deceased beginning thus - I Goodwin Borne
 In the name of God, making thus - This witness all
 after Wills made by me. I do put my hand

and seal to this 11th of July one thousand seven hundred and
 ninety three and thus subscribed, Goodwin Borne.

They further made oath that they verily in their con-
 science believe the whole was and of the same paper
 writing beginning ending and subscribed as aforesaid to
 be of the proper hand writing and subscription of the said
 Goodwin Borne deceased.
