I William Satter of the County of Bladen State of North Carolina being of sound mind and disposing memory. Blessed be to god for his mercies. do make and publish this my last Will and testament in manner and form following. viz:

I desire that all my just debts be paid and funeral expenses.

I give and bequeath to my beloved wife Elizabeth Satter the following negroes. together with their increase. viz: Betty, Lucy, Anna, and Nancy. all my stock of Cattle Household and Kitchen furniture during her natural life time and at her death. to be disposed of as hereafter will be stated.

I give and bequeath unto my son John D. Satter for the use and benefit of my daughter Elizabeth Satter at the death of my wife Elizabeth one negro girl named Nancy.

I give and bequeath unto my son John D. Satter for the use and benefit of my daughter Sarah Bryan, and her heirs at the death of my wife Elizabeth Satter one negro girl named Anna. and her increase forever. though considering that Anna to be worth more than Nancy who I gave to my daughter Elizabeth therefore Sarah Bryan is to pay Elizabeth Satter fifty dollars on her taking Anna. into possession.

I give and bequeath unto my son John D. Satter his heirs Executors Administrators and assigns. One negro boy named John. also at the death of my wife Elizabeth Satter I give to my son John. Betty, and Lucy.

As to my stock Cattle and Household and Kitchen furniture it is my Will and desire that my wife Elizabeth have the right to do anything she may wish with it so

I give and bequeath to my son James Satter and my son Joseph D. Satter fifty cents
