MINUTES OF THE COURT GRANVILLE COUNTY, NORTH CAROLINA 1818-1820

November Term 1818 - Court convened November 4, 1818- Negroes of THOMAS VOSS, deceased, to be sold by CHARLES SMITH, administrator of estate to make distribution among heirs. Grand Jury qualified; Petit Jury qualified. Jurors drawn to attend February Courts. Overseers appointed for roads. Will of JESSE GARROTT, deceased, proved by BETSEY BARR, and SAMUEL RUST became executor. Will of MARY MINOR, deceased, proved by SAMUEL RUST who had been named executor but refused to qualify, so GEORGE STROUD qualified as executor, with WILLIAM BUTLER as security. CLABORN COOKE became executor of will of DUDLEY HOUZE which was probated February 1817; SARAH HOUZE relinquished property willed to her by DUDLEY HOUZE, deceased, her late husband, that it might be sold and divided among the legatees. Overseers appointed for roads. Deeds proved and ordered registered. Power of attorney from MARY OWEN to THOMAS MONTAGUE and from JOHN KNIGHT to WILLIAM OWEN. WILLIAM WEATHERS and wife PRISCILLA deed to JOHN BRADFORD 106 acres and she gives consent to same. WILLIAM WEATHERS and wife deed to JEFFREY PEARCE 243 acres with her consent. Administration on will of PATRICK OBRIEN, deceased, granted to administrators and sell negro to pay debts. Administration of estate of JAMES H. KITTRELL, deceased, granted to ROBERT JONES, with DANIEL and LEWELLEN JONES as bondsmen. JOHN LANDERS sued LESLIE GILLIAM for debt. THOMAS Y. COOKE returns his list of taxables of Fort Creek district. Deed from R. COOKE to DANIEL GOOCH for 300 acres proved by THOMAS WEBB. Deed of gift from JOS-EPH GILL to DRUCILLA S. GILL for 2 negroes. Deed of gift from JOSEPH GILL to SALLY T. GILL for 3 negroes and gift to FRANCES E. GILL for 2 negroes. Lists of taxables returned to court. BOSWELL COOKE sued JAMES G. LAMORE for debt. ROWLAND GOOCH deeds in trust to DANIEL GOOCH, trustee, for benefit of SUSANNAH LANDERS for negro ELDRIDGE and also a negro CAESAR for benefit of JAMES GOOCH. Will of THOMAS NORMAN, SR., deceased, proved by THOMAS W. NORMAN and SARAH NORMAN, executors
