e.	or all men once to die. I hereby make and ordain this my will
	ment infollowing, that today 1st and principally, I give
and testar	th my soul into the hands of Almighty God that gave it to me,
and beques	th my soul into the hands of Almagney to the hands of
nothing do	oubting that I shall receive the same again from the hands of
my	blessed Redeemer at the Day of General Resurrection and my
body to th	e earth from whence it came to be buried in a Christian decent
manner at	the discretion of my executors whom I shall hereafter appoint, &
as for wha	t worldly goods it hath been please God to bestow upon me. After
my just de	bts and funeral expenses are paid I give and bequeath as followth:
IMPRIMIS:	I give and bequeath to my beloved wife CATHERINE MACKLEROY, 3
Ac	negroes named Cesar, Jane & Doll, and 1 stallion called Bull,
	and the plantation whereon I now live during her life (Catherine
	Simpson ? - died by June 1776).
ITEM:	I give and bequeath to my beloved grandson, MICAJAH MACKLEROY,
	the plantation and tract of land on Crabtree Creek whereon James
	Childres formerly dwelt and 1 negro boy named Cook to him and his
	heirs forever. (Rev. soldier - died Lincoln Co., Tenn., 1834).
ITEM:	I give and bequeath to my beloved son named AVONTON MACKLEROY, my
	mill and all the land adjoining to it as low as Polk's branch, &
	l negro boy named Buck, to him & his heirs forever. (married
	Sarah Dawson 3/7/1770, daughter of William and Martha Dawson -
	will 3/15/1789 - recorded 5/30/1797).
ITEM:	I give and bequeath unto my beloved son, JOHN MACKLEROY, the
	plantation and part of the tract of land I now live on after
	the decease of my wife Catherine & 1 negro boy named Peter, to
	him and his heirs forever. (Died 1793/94).

WILL OF ARCHIBALD MOELROY, SR.

ITEM:

I give and bequeath to my beloved son, ANDREW MACKLEROY, 100 acres of land taken out of the tract I now live on lying on Marsh Creek and not coming nearer the plantation than the rod hill, and 1 negro boy named Will, to him & his heirs forever. (Revolutionary soldier - Oglethorpe: Co., Ga., and Alabama - See Pension Record).

ITEM:

I give and bequeath to my beloved daughter, SALLEY, 100 acres of land out of the tract I now live on adjoining the land left to my son Andrew, at the lower end of his land, & 1 negro girl named clos, to her and her heirs forever, and also, 1 mare called Poll.

ITEM:

I give and bequeath to my beloved daughter FRANKEY (Frances) the upper end of North Creek land called the hog farm, & 1 negro boy named Dick, to her and her heirs forever. (married John Baptist Shaw 12/3/1771).

ITEM:

My will and desire if that if it should please God any of my children above mentioned or my grandchild, MICAJAH (son of Archibald Mackleroy, Jr.), should die before they come of age, the boys 21 and the girls 16, or married, having lawfully ______ that then his or her part to be equally divided among the survivors.

ITEM:

My will & desire is that all the remainder of my estate, both real and personal, may be equally divided between my wife and children at the discretion of my executors for my desire is that my estate be inventoried but not appraised.

I do hereby appoint my beloved wife, CATHERINE MACKLEROY, executrix, and my brother WILLIAM, and my friend ANDREW HARTSFIELD, executors of this my last will & testament, revoking all the wills formerly by me made.

Allowing this and no other to be my last wil & testament, THOS. HUNTER & NATHANIEL JONES to assist in dividing the estate. In witness whereof, I do unto set my hand and seal this 9th day of December 1760.

Jan. 1761 ---- ARCHIBALD MCELROY'S will was proved by James Chatwin, CATHERINE, widow, and WILLIAM MCELROY and ANDREW HARTSFIELD, executrix and executors.

April 1761, SARAH McELROY, widow of ARCHIBALD McELROY, JR., dec'd, returned inventory of her husband's estate.

SARAH MCELROY, widow of ARCHIBALD MCELROY, JR., dec'd, granted administrator on the estate with JAMES LINN and JOHN ROACH (?), securities.

Ordered that SARAH McELROY, widow of Archibald, McElroy, Jr., dec'd, be appointed guardian of her child, MICAJAH McELROY, orphan of said deceased. (MICAJAH, native of N.C. b. 9/30/1760, d. 1834 Lincoln Co., Tenn.)

ARCHIBALD McELROY, JR., married Sarah Lynn.
