Will of John Harrison

In the name of God Amen I John Harrison of the County
of Johnston and State of North Carolina being of sound
mind and memory blessed be God for the same do this
twenty seventh day of April in the year of our Lord one
thousand eight hundred and twenty one make and ordain
and publish this to be my last will and testament in
manner and form following (that is to say)

Item It is my will and desire that all my just debts should
be paid and such part of my perishable property sold
so that purpose as can best and most conveniently be
spared to be at the discretion of my executors hereinafter
to be named and after selling such part of said prop-
erty as can well be spared so as to leave my family a
reasonable part or share to live on then it is my desire
that the deficiency which may be lacking towards paying
of my debts that then the said executors shall proceed to
sell such part of my lands as they may deem proper
sufficient to satisfy said debts taking it at the lower
end of my land beginning at the creek and running from
thence out to the back line in such a manner and at
what place my said executors may think best.

Item I give to my beloved son Elisha Harrison one year old
colt called by name Wingo.

Item I lend all the rest of my property both real and
perishable unto my beloved wife Delila Harrison
during her natural life or until my son Zachariah
Harrison shall arrive to the age of twenty one years
and at her death or if she should live until Zach-
ariah arrives to the age of twenty one then I wish

the whole of said property which may not be consumed
in raising of my family and supporting them to be sold
and an equal division made amongst my wife and
children equally only if my wife can find that it can
well be spared I should be glad that as my children
arrives to the age of twenty one or marries that she should
give them a bed & furniture each and a cow and calf. And I
do hereby make and ordain my son James Harrison and my
friend Bud Youngblood my executors to this my last will
and testament in witness whereof I have hereunto set my
hand and seal the day & date above written.

Will of William Bryan

In the name of God Amen I William Bryan Sr of
Swift-Creek in the county of Johnston and State of
North Carolina being sick and weak of body but
of sound and disposing mind and memory for which
I am truly thankful to the great and wise disposer
of all events do make and ordain this my last will and
testament as follows (to wit)

Item I give & bequeath unto my beloved daughter Betsey Vinson
Hinton wife of William Hinton one negro man named
Roderick and one negro woman named Hannah now in
their possession one feather bed bedstead and furniture also
in their possession together with other small property
formerly my own but now in their possession also fifty
dollars in cash to her her heirs and assigns forever.

Item I give and bequeath unto my beloved daughter Rebecca
Stallings wife of James Stallings one negro man named
Hampton, one negro woman named Amy and her child named
Simon one bed bedstead and furniture together with other
small articles of property now in their possession and also
fifty dollars in cash which I advanced & paid over the said

James Stallings sometime past to her and he, heis assigns
forever

Item I give and bequeath unto my beloved son Medham Bryan all
the land I own on the east side and below Holders Branch one
negro man named Peter one negro woman named Betty one bay
horse called Buck three cows and calves two young steers six
and hams all my hogs which he feeds on said lands except the
of two years old one feather bed bedstead and furniture also
one fourth part of my working and plantation tools to him and he
his and assigns forever.

Item I give and bequeath unto my son Samuel Washington Bryan
my lands on the west side and above Holders Branch on the
North side of Swift Creek together with about fifty or six
acres of my land on the south side of said creek adjoining
the lands of Benjamin Carrell to him and his heirs and
assigns forever.

Item I give and bequeath unto my beloved daughter Senelia
Bryan my beloved son Samuel Washington Bryan and to my beloved
daughter Mary Turner Bryan the following negroes (to wit) one
woman named Doll & her child Dorcas, one woman named
Judy and her child York, one woman named Lydia, one boy
named Sandy, one boy named George in common and the equal
part to be by them or either of them possessed when they or
either of them may marry or arrive at full age and should
either or any of them die before they marry or arrive at full
age it is my desire that the survivor or survivors of them may
and hold the whole of the aforesaid last mentioned negroes and
also give and bequeath as last aforesaid one negro boy named
Ruffin and to each of them one feather bed bedstead & furniture
to them and their heirs and assigns forever and all and full
one negro boy named Guilford.

Item I give and bequeath unto my beloved wife Edith Bryan
for and during her natural life the use of my land and
plantation which I heretofore in this will give and bequeath
to my son Samuel Washington Bryan and also during his natural
life the use of the aforesaid nine negroes given as aforesaid
to my said three children in common unless they or either
of them should marry or arrive at full age then and in
that case to have their equal part as aforesaid and
also for and during her natural life one negro man
named Baillian, one named Dick one named Moses
and it is considered and is my desire that this gift
be for the benefit of my said wife and three youngest

children for supporting for supporting her and the said three
children and also educating them also all my household and
kitchen furniture my working tools except such part thereof
given to my son Medham as aforesaid three head of hogs
called Doll, Jack and one mule and also all of my stock
of cattle, hogs and sheep except such part thereof which
are therein after directed to be sold also my eider corks
and still worn and cap and a sufficient support for
my wife and family for one year to be allotted to her
by my executor hereafter named also my work steers
and cart

Item It is my will & desire that after the death of my
wife Edith the aforesaid three negroes Brittain Dick
and Moses shall belong equally to my three eldest children
Peter Vinson Hinton Morrisa Stallings & Medham Bryan
which I give to them and to their heirs and assigns
forever and it is further my will and desire that the
residue of my property willed to my wife Edith except
the three last mentioned negroes go and I hereby give
the same to my three youngest children to them and
their heirs forever.

Item It is my will and desire that my two negroes Mingo
and Sena be hired out by my executor for the space
of seven years and the monies arising therefrom together
with said negroes Mingo and Sena I give and bequeath
to my grand daughter Patsy Vinson to her and her heirs
and assigns forever except one hundred dollars of said
hire which I give to my grandson John William Watson
but should the said Patsy Vinson die before she marries or
becomes of lawful age the said hire of negro and the
said negro to revert to my lawful heirs in common

Item It is my will and desire that my executor hereafter
named sell at their discretion and at private sale during
there be no publick sale my residue of the stock & crop
except for the support of my wife and family as aforesaid
they first fattening the hogs and keeping the residue of
the corn until next Summer.

Item I give and bequeath unto my ^{grand} son John William Watson
one negro woman named Pagar and one hundred dollars
as aforesaid to him his heirs and assigns forever.

Item It is my will and desire that my executor sell

twelve months credit one small tract of land containing about forty or fifty acres lying on the south side of Deep creek adjoining the lands of Jesse Wood Jr and monies arising therefrom to be equally divided amongst my six children together with my note standing debts and I hereby constitute and appoint my son-in-law James Stallings and William Hinton executors to this my last will and testament revoking and making void all wills and testaments by me heretofore made satisfying and confirming this to be ^{found as the} my last will and testament. In witness whereof I the said William Bryan have to this my last will and testament set my hand and affixed my seal the seventh day of October A.D. 1821
