First. My executor, hereinafter named, shall give my body a decent burial, suitable to the wishes of my friends and relatives, and pay all funeral expenses, together with all of my just debts, out of the first monies which may come into his hands belonging to my estate.

Second. I give and devise unto the children of Louvinia Parrot my Grand Children, Jane Pitts, and Oscar, my lot of land lying in the town of Winston on Shine and Queen Streets which I purchased of W. C. Garrett adjoining John R. Phillips lot and the lot of Fred Jones. It is my will and desire that Louvinia Parrot the mother of the said children shall stay on the said lot with the said children her lifetime if they can agree.

Third. I will an - bequeath to my grand child Jane Parrot daughter of Louvinia Parrot my fine dogs. One bed, bed cloths and bed furniture, I give to my grand son Oscar Dilgman and my son William Haywood Broom. The other bed bedfurniture and bed cloths, I give to my two grand children Jane Parrot and Pitts Cobb. All the balance of my property not herein otherwise disposed of I give to my three grand children, Jane, Pitts and Oscar Dilgman to be equally divided between them.

Fourth. I hereby constitute and appoint my friend Charles Dunn my lawful executor to all intents and purposes to execute this my last will and testament, according to the true intent and meaning of the same, and every part and clause thereof. hereby revoking and declaring utterly void all other wills and testaments by me hitherto made.
