to Lucy Davis to be and remain the entire property of
her and her heirs.

All the residue of the property of whatever kind I will and
direct that it be equally divided among all my surviving

I do hereby constitute and appoint my son Isaac
the executor of this my last Will & Testament.

February & year 1810.

the County of Mecklenburg State of North Carolina
being weak of body but of sound & perfect mind & memory
thankful to God for the same do this 22nd day of August in the
year of our Lord 1810 constablate. Make publish and
declare this my last will & testament in manner and
form following 183

First I give & bequeath unto my loving wife Martha Wilson
the my dwelling house where I now live with all the
real houses & the orchard of this plantation during her
natural life and no longer, I also give & bequeath con-
siderable number of slaves my loving wife more & gratis

during, his natural life and no longer, I also give unto my
loving wife all my house & kitchen, furniture as they now
are standing, in natural life, I also give unto my loving
wife one little spinning wheel & one light wheel loj, then with
one saddle & bridle, my large Bible, Petward on Regeneration.
All my goods works with all my stock of horses & sheep & hogs
and my Negro woman Liza, forever, And I also give unto
my wife Martha the full use of all my spinning Utensils
& Tools along with my Negro man Camp during her na-
tural life & no longer.

2^d I also give & bequeath unto my Daughter Sarah Robison
my negro child Harriet forever.

3^d I give & bequeath unto my son James Taylor the land my
Negro boy child named Berwick, or to be his during his natural
life and at his death to descend to his natural issue, if
he has no issue then to be sold & equally divided between
my two Daughters Deborah Robison & Sarah Robison &
my two Sons Ezekiel & Wallace Alexander.

4th I give & bequeath unto my son Wallace Alexander all
my plantation 220 acres adjoining my son Ezekiel's &
to be divided from his land to his said Wallace forever
and I also give unto my said son Wallace my Negro man
Camp at my wife Martha's deceased to be his forever.

5th I give & bequeath unto my son Ezekiel the land of my
son Ezekiel Robison One hundred & fifty acres of Land east
to be subdivided from Berwick off on one Acre of my Robison
land tract on Duck Creek bounded west, and the remaining
one hundred acres of said Robison land tract to be sold to
equally divided between Deborah & Sarah Robison &
Wallace & James Taylor & their issue.

And the remainder & other land of my estate personal & real
not willed herein, I allow to be sold at my wife's direction
and to be equally divided amongst all my children
Deborah & Ezekiel Mecklenburg Co., NC Wills #17834844 and James Taylor

My negro works with all my Stock of Cows & Sheep & Hogs
and my Negro Mountain Linn, Linen, Wool I also give unto
my wife Martha the full use of all my Servants
& Servantes with my Negro man Camp during her ha-
lved life & no longer

2^d I also give & bequeath unto my Daughter Sarah Robison
my negro Child Harriet forever.

3^d I give & bequeath unto my son James Taylor the under my
Negro boy Child named Derrick, or to be his during his natural
life and at his death to descend to his natural issue, if
he has no issue then to be sold & equally divided between
my two Daughters Deborah Robison & Sarah Robison &
my two Sons Ezekiel & Wallace Alexander.

4^r I give & bequeath unto my son Wallace Alexander all
my plantation 220 acres adjoining my son Ezekiel's &
is subdivided from his land to be said Wallace forever
and I also give unto my said Son Wallace my Negro man

Camp at my wife Martha's deceased to be his, forever.

5^t I give & bequeath unto my son Ezekiel the under my son
Son Ezekiel Robison One hundred & fifty acres of Land each
to be subdivided from Lands off the one fourth of my plantation
line tract on Dark River bounded and the remaining in
one hundred acres off said thousand acre tract to be sold &
equally divided between Deborah & Sarah Robison &
Wallace & James Taylor other and so forth.

And the remainder & remanences of my estate personal & real
not heretofore sold I allow to be sold at my wife's direction
and to be equally divided amongst all my Child
Deborah & Sarah Robison, Ezekiel Wallace and James Taylor
other and after my first & legal debts & paid out of it
and my debts owing to me.

And I do hereby appoint my son Ezekiel & Alexander
Grandson Ezekiel Robison & my Trust friend James
Alexander my executors to be to this

Will & Testament, the date is whereof I have inserted in my
hand and seal this 22nd day of August in the year of our Lord 1783

into the hands of Almighty God to keep safe, to keep body to the
earth to be buried at the place whereof any convenient
and convenient shall be readily made wherewith it has place
and God shall be exalted in his spirit. Give due notice & disposal of this now
in the following manner & form -

I give & bequeath to Polly my dear beloved wife the plantation
whereon I now live together with Horses, Hounds, Cows, Sheep
& Hogs likewise farming Elizabetts House & Kitchen, premises
during her widowhood.

I give to my Son Parmonas an equal Division of my lands
estate at the decease of my wife or in case she marries -

I give to George my second son the same with Parmonas -

I give to my Daughter George & Joseph both called Bucks -

I give & bequeath to my Sons: Parmonas, August (as above
mentioned) & Joseph, Wilson, John, Elam & Sam as equal
Divisions of my landed Estate to share & take at the
decease of my wife or in case she marries as above
mentioned - - I hereby Ordain & Appoint my wife Polly
my Son Parmonas & my Brother in law George to take and
execute of this my said Will and Testament sealing &
confirming this 4th Month in my last Will & Testament - In
the year of our Lord 1783 -
