and furniture one place & two pair of Geese & Ten pounds worth of  
Household furniture, I do bequeath to my son James & each of my  
Daughters one pound. I do bequeath each to each of my three grandsons  
named for me ten dollars when they are at the age of Twenty  
one years. And lastly as to the rest residue & remainder of my  
real & personal estate of whatsoever kind I give & bequeath to my  
Younger Son Matthew whom I do appoint with my beloved  
wife Jane sole Executrix of this my last Will & Testament, hereby  
repealing all former wills by me made. In witness hereunto  
I have set my hand & seal this 20<sup>th</sup> day of August in the year  
of our Lord 1802 & the 27<sup>th</sup> of American Independence.

Carolina & County of Rockingham, being weak of body, but of  
perfect sense & memory blessed by God, Do make & execute, apparent  
herein to be this my last will & Testament in manner & form  
following, i.e., First I give my soul to God, from whom I  
received it, my body I commit to this Earth to be buried in  
a decent Christian manner at the discretion of my Executrix  
and as for what worldly goods it has pleased God to bestow  
on me I give & bequeath in manner & form following, to wit  
First I give & bequeath to my wife and wife Nancy Hargold  
the said plantation between me & her with all my stock  
consisting of Hogs Horses & cattle Household furniture of all kinds  
working tools, Utensils, & other goods & chattels that I am possessed  
of one hundred acres of land at the Stump Creek after all just debts  
expended, with one cow called Tilly given to Elizabeth Henry

One half to James Cherry, one half to Jane Craig one half to  
 & William Cherry Junr. one half to each traveller except the  
 above gifts all my last goods chattels & property I give to my  
 well beloved wife Anna Hargott during her natural life &  
 after her decease it is my last will & testimony that the whole  
 estate real & personal be equally divided among my children  
 Henry Hargott and Elizabeth Cherry, Peter Hargott, Rachel  
 Bellon, Rebecca Brown, Joseph Hargott, Mary Craig, Sarah  
 Hobson, Daniel Hargott, Agnes Lucy. Lastly I nominate  
 Agnes Lucy & conste take this my last will & Testament in witness  
 of my beloved Sons Henry Hargott Junr. & Joseph Hargott Exec't  
 to this my last will & Testament In witness whereof I the  
 said Henry Hargott Junr. have hereunto set my hand & seal this  
 28<sup>th</sup> day of March 1803.

 being in a sick & low condition but of sound & perfect mind  
 & memory blessed be God, do make & publish this my last will

 during her natural life eight negroes viz Lucy, Frank  
 Frederick, Anna, Charly, Hager, Sylvia & Prudy and all the household  
 furniture which includes all the beds & bedding, Tables, Dish, Cup  
 - board &c all which are or may be in her possession also one Bay  
 Horse also the right to occupy myself & enjoy all the rights & privileges  
 on or into one certain tract of about 900 acres of land that I bought  
 of Adam Brown all the above I give she is to suffice during her  
 natural life & then to descend to her children as her aforesaid directed  
 Item I give & bequeath to my beloved Grand daughter Sarah Harper  
 Dorothea one negro Woman named Barbara one negro girl named  
 Peggy, one negro boy named Sandy & one negro boy named Moses to  
 gather with them increase or issue from this time & on to the partition
