Sugar creek beginning at *Ezra Alexander's* bridge, thence
with my & *Abner's* conditional line to a Stake in *D. Abner's*
line of his new survey & from thence to the beginning corner
of the old survey being a dead Pine, from thence to a post in
said *Abner's* corner from thence to a Post Oak corner of
said *Abner's* corner to widens *Dorcas Alexander's* line with
said *Dorcas's* line to *Paris Alexander's* corner
Little Sugar Creek, thence with said *Dorcas's* line to the creek

 as Executors of this my last Will & Testament. In
