I Give and Bequeath Unto My Son James Ten Dollars. I Give and Bequeath Unto My Son John My Bay Mare and Sac Guineas. I Give and Bequeath Unto my Daughter Jean Sac Guineas. I give and Bequeath Unto Margret Logen Daughter to John Logen five Dollars I Give And Bequeath Unto Sarah Logen Daughter to John Logen One Yearling Heifer. I Give and Bequeath unto John Logen Jun^r Ten Dollars and my Hat I Give and Bequeath Unto John Logen Jun^r Ten Dollars I Give and Bequeath Unto Andrew Logen Son of John Logen Eight Dollars and My Plough Irons I Give and Bequeath Unto My Daughter Sarah Askins one Gun and Two Pots Now in her Possession to her and her heirs The Ballance of My Estate after paying My just Debts My Devise is that it shall be Equally divided amongst all My Children
