

WILL OF

SAMUEL DALRUMPLE

In the name of God Amen, I Samuel Dalrumples of Abbeville County, being very weak and low in body, but in perfect mind and memory, calling to mind, that it is appointed for Men once to die, I do make and ordain this to be my last will and testament, and as God has been pleased to blefs me with a portion of this worldly goods, I do divide in the manner and form following, that is to say, first of all give my soul into the hands of God that gave it, and my body to be buried, in a Christian manner at the discretion of my Executors.

I do give and bequeath to my beloved wife Sarah, one third part of my movable estate, and one negro boy to help to raise the Children, and one thrid part of the plantation and tract of land where I now live, the negro and land to be my wifes during lifetime or widowhood. and then to return to my Son James--Secondly I give to my daughter Racheal Laughlin, one hundred and twenty five acres of land, part of a tract lying on Rocky river, one feather bed and furniture, one hunting saddle one one cow and calf.-- I give and bequeath to my beloved daughters Sarah, Mary, and Elisabeth one tract of land, containing six hundred and seventy acres of land, lying on the head cold water a branch of Rocky river, and each of them one hunting saddle, and cloak to Elisabeth but if the land should be lost, then the value thereof shall be made up out of the rest of my movable state. I give to my beloved Son James, the plantation and tract of whereon I now live, containing three hundred and thirty acres, and one bay mare and sorel colt two years old. I give my Nephew Samuel Dalrumples, the sorel mare colt and half a year's schooling and the colt be raised till two years old.

I do divide in the manner and form following, that is to say first of all give my soul into the hands of God that gave it, and my body to be buried, in a Christian manner at the discretion of my Executors.

I do give and bequeath to my beloved wife Sarah, one third part of my movable estate, and one negro boy to help to raise the Children, and one thrid part of the plantation and tract of land where I now live, the negro and land to be my wifes during life-time or widowhood. and then to return to my Son James--Secondly I give to my daughter Racheal Laughlin, one hundred and twenty five acres of land, part of a tract lying on Rocky river, one feather bed and furniture, one hunting saddle one one cow and calf.-- I give and bequeath to my beloved daughters Sarah, Mary, and Elisabeth one tract of land, containing six hundred and seventy acres of land, lying on the head cold water a branch of Rocky river, and each of them one hunting saddle, and cloak to Elisabeth but if the land should be lost, then the value thereof shall be made up out of the rest of my movable state. I give my Nephew Samuel Dalrump, the sorel mare colt and half a year's schooling and the colt be raised till two years old.

I give and bequeath, to my four youngest children to wit- Ann, Elinor, Rosannah and Rabeckah, one plantation and tract of land containing two hundred acres, to be equally divided, the land lying on Brush river.

And after all my debts being paid, then the rest of my estate to be divided between my wife and all my Children if any remain.--

And I do appoint my wife executrix and my Brother John Dalrumple executor of this my last will and testament, and I do hereby disanul all other wills and testaments, gifts and bequeaths whatsoever heretofore given willed or bequeathed, and do hereby acknowledge this to be my last will and testament, given from under my hand and seal this twenty first day of November 1791.
