SAMUEL WARREN

State of South Carolina.

In the Name of God Amen- I Samuel Warren of the Parish of St James Santee and State aforesaid, being in my Senses, do with my own Hand write this my last Will & Testament in Manner and form following- ----

1st I give to Lydia Ann Miller all my Silver and plated ware, of every denomination & my Gold Watch, but in no event to be subject to her Husbands debts. 2nd I give to John Miller her Husband of Pendleton, All my wearing apparel & gold Sleeve buttons. 3 I give to Samuel Fenner Warren Miller of Pendleton my Mahogany writing ~~desks~~ Seals and what Books I may have at Soldiers Retreat Pendleton. 4 I give to my Friend Rebekah Verree my three Volumes of Goadby's Bible. 5th I give to Warren DuPre' my two Book Cases at Echaw Grove, the one Mahogany, the other Cypress with one half my Books at Echaw Grove, Goadby's Bible & the Acts of the Legislature with Grimkies digest excepted which are bound up, Goadbys Bible I have given to my Friend Rebekah Verree in the 4th place, & Grimkies digest and the Acts, I give to the College at Columbia, where they will be preserved----- the other half of the Books I give to Samuel Warren White. 6th I give the use of the following Negroes & the increase of the Females, at Soldiers retreat Pendleton, that is to say October, August, June, Prince, Cruso, Geddais, Bacchus, Cesar, William, Pollidore, November, Ajax, Teresa, Camilla, Sulvia, Magdalen Hagar, Witty, Binky, Sucky, little William, Jack, Matilda, Daphne, Mira, Mary, Nero, Cardenio, Hannah & Rachel in all Thirty, to Lydia Ann Miller aforesaid during her natural Life, but in no case whatever to be in any manner subject

1st I give to Lydia Ann Miller all my Silver and plated ware
of every denomination & my Gold Watch, but in no event to be
subject to her Husbands debts. 2nd I give to John Miller her
Husband of Pendleton, All my wearing apparel & gold Sleeve
buttons. 3 I give to Samuel Fanner Warren Miller of Pendleton

Rachel in all Thirty, to Lydia Ann Miller aforesaid during her
natural Life, but in no case whatever to be in any manner subject
to the debts of her Husband John Miller, and at her death to the
use of all her Children by John Miller equally and as they attain
the age Twenty one years or day of Marriage each Child taking
his or her share, but should any Child die under the Age of Twen-
ty one years leaving no Issue, his or her share to go to the
Surviving Children of Lydia Ann Miller, by John Miller, and in
case of the death of John Miller & Lydia Ann Miller Marrying

7th I give the use of my Plantation at Pendleton call'd Soldiers retreat near Pendleton Village containing about four hundred & fifty Acres also about five Acres I bought of Smith Heaton on the opposite side of the Creek, also my half of the adjoining Mill, of which John Miller ownes one half with my proportion of the land attached to it, to Lydia Ann Miller during her natural life, but in no case to be liable for the payment of any of her Husband John Miller debts and at her death to the use of all the Children She may have by John Miller,

~~until they all attain the age of Twenty one years or Marry &~~ then to Samuel Fenner Warren Miller, his heirs Exors and afsigns forever. 8th I give the use of my Stock of every kind and Furniture at Soldiers retreat to Lydia Ann Miller, on the same

conditions as the use of the Negroes are given. 9th It is my

will and desire that my Plantation commonly call'd Echaw Grove, with all the Negroes on it, Stock of every kind & furniture be sold on the best terms my Creditors will give to pay ~~my~~ my debts, & should it more than pay my debts the balance to Lydia

Ann Miller on the same conditions as the use of the Negroes are given, that is to say the interest only to be spent during Lydia Ann Millers natural life, or while the Children are under age or unmarried- 10 in witness whereof I have hereunto set
