Anderson District ) Cox Sen<sup>r</sup> of Said State and District  
being in a low State of health but of Sound disposing mind and  
memory and Knowing that it is appointed unto man to die do make  
and constitute this my last will and testament and as touching  
Such worldly goods as God hath blefsed me with in this life do  
dispose and bequeath the same in the following mannor and form  
(viz)

First My will is that my body be interred in decent order at  
the discription of my friends

Second that all of my Just debts be paid Satisfactory

Third that all of my property boath real and personal notes  
and money be devided between my belved wife Elizabeth and each  
of my children (viz) Barbary, John Polly Thomas Elizabeth and  
~~William~~ as the law directs considering that what I have given  
them during of my life to be equal shares to each and that each  
of them are to retain in there own hands what ever they may now  
have in possefsion all the portion of my estate that my Daughter  
Barbary receives which is an equal share with the rest I put  
in the hands of my son William Cox whom I appoint as her Guard-  
ian to dispose of the same as he may think best for her use and  
benefit as long as she shal live at her death the remaining  
portion to be equally devided among the lawful heirs of her Bod-  
dy to be for there Special use and benefit as long as they may  
live and if my son William should depart this life before such  
disposition is made his Executors or administrators or a guard-  
ian that may be appointed is to carry into effect my will in  
relation to that portion that is for the use and benefit of my  
daughter Barbary Harper and further and lastly I appoint my he-
