I do give and bequeath unto my sister Anna Anderson, Anna of the boy is John P. Carr and the names of the two Girls be not now to me the live issue and the 1/3rd named above to have one half of my real Estate Equally divided. I do will unto my three late brothers and Sisters as follows the other half of my real Estate to be divided into six Shares Joseph C. Carr to have three Shares, John Carr to have one one share C. Carr and John and Kelly Carr each one share Lastly I do hereby constitute and appoint Joseph Carr and Joseph Alexander Executors of this my last will and testament and hereby seeking all others former wills or testaments by me made in witness whereof I have hereunto set my hand and seal this 5th day of April in the year of our Lord 1822.

In the name of God Amen I Henry Pettisfield of the State of Tennessee and County of Blount do make and publish this my last will and testament hereby revoking and making void all other wills by me at any time made. I do will that all my property personal and real estate be sold according to Law, and the proceeds be equally divided amongst my heirs as soon after my death as the Law requires it to be done. State of Tennessee Blount County March 23, 1825
Willie Rogers of the above named State and County being sick and weak of body but of sound mind and memory for a short time to thank God, Calling to mind the uncertainty of human life and being desirous to give peace of all such worldly substance as it hath pleased God to bless me with, I give and bequeath in manner following that is to say, It is my will that all my just debts be paid. Then I do It is my will that my wife Mary Rogers shall have the use and all the profits of all the live stock in hand at my decease and also the house I now live in together with all the out houses belonging to said dead house, also all the household furniture that may belong to me at my decease this to have and to hold during her natural life and that she shall have her support one third of all the production of the farm I now live on and at the death of my wife Mary Rogers it is my will that my son David and she shall have the part of the plantation lying behind the publick Road by paying my daughter Zephania thirty dollars in good trade at trade rates. It is also my will that my daughter Sally shall have at the death of my wife the part of the farm lying above the publick Road by paying my daughter Zephania twenty dollars in good trade at trade rates. It is my will that at the death of my wife that my Grand Son Willie Davis shall have when he be comes of age one half and Common Furniture belonging thereto and that S. C. Cox shall have one black and white hifer that are now in the farm also all the increase of said hifer. It is also my will that at the decease of my wife that all the household furniture and use the stock of my wife is caption to divide and
