Hope Cemetery near Chicago, Ill; However should this be done before my demise, I give and bequeath the amount so desired expended to my brother Nichola's widow Lucy M. Clute of Chicago, Ill. but in case she does not survive me then this amount I give and bequeath to my brother Fred P. Clute.

Third. I give and bequeath the balance of my estate either real or personal to my beloved brother Fred P. Clute.

I hereby nominate and appoint Fred P. Clute my sole executor without bond.
