I Jacob Freshour, a citizen and resident of Blount County, Tennessee, being mindful of the uncertainty of life's tenure, and being desirous of directing the disposition and ownership of the worldly goods, which I have accumulated, after my death, do hereby make, publish and declare this my last will and Testament.

Item 1st.

I direct that all my debts and funeral expenses be promptly paid, out of the first money coming to the hands of my Executor.

Item 2nd,

I direct that my Executor, at the expense of my personal estate, cause suitable and decent tomb-stones to be placed at the graves of myself and of my wife- Elizabeth Freshour.

Item 3 I give and bequeath to my Sister Mary Webb- wife of Henry Webb the sum of one hundred dollars.

Item 4

I give and bequeath to my Sister- Elizabeth Henry wife of Rev. P. H. Henry the sum of one hundred and fifty dollars

Item 5

I give and bequeath to my Sister Ann C. Tipton-widow of J. W. H. Tipton, dec'd. the sum of one hundred dollars.

Item 6th

I give and bequeath to my niece Alice Russell-widow of Dr. Henry Russell dec'd. the sum of fifty dollars.

Item 7th

I give and bequeath to my neice Elizabeth Wester- wife of R. L. Wester, fifty dollars.

Item 8th

To my friend Samuel A. Farmer who has been with me from his early boyhood, and has by his prudence and industry ~~had~~ greatly assisted me in the accumulation of my small worldly estate, and for whom and for whose family I desire to make provision out of my estate, to the said Samuel A. Farmer, I give devise and bequeath all my lands and real estate, wherever located and situated, as an estate of inheritance and fee simple and unencumbered, except as specified in the next items of this will; and I also give and bequeath to my said Friend Samuel A. Farmer, all the rest, residue and remainder of my personal

property, of every description whatsoever, thus making him my residuary legatee.

Item 9.

I direct that my Executor pay to the said legatees mentioned in Items 3-4-5-6 & 7 the several legacies therein bequeathed to them, within two years after my death; and to secure the certain payment of the said legacies, I make them and each of them a lien and a charge upon the lands and real estate described to Samuel A. Farmer

Item 10th

I hereby nominate, constitute and appoint my said Friend- Samuel A. Farmer, Executor of this my last will and testament and release him from giving any bond to the Court as such Executor.
