IN RE HETTY A. FIELDS.

Greenback, Tenn. Nov. 15, 1916.

I Hetty A. Fields being of sound mind do make this my last will.

I want all expenses and indebtedness paid after my death, then

I give to my daughter Minnie Ann Hammontree the proceeds derived <sup>And remain on the Farm</sup> from the farm (known as the Tulloch farm) so long as she lives, Minnie Ann Hammontree to keep taxes paid on the same. No timber to be used except to keep up farm and fires.

I Hetty A. Fields want the above farm to go to Samuel Tulloch Hammontree and Hetty Ellen Hammontree after the death of their mother. In case either one of them die then the farm goes to the living one, I case they both die before they come in possession of same then the farm is to go to the remaining heirs of Minnie Ann Hammontree.

The farm known as the Geo Fields farm in Monroe County is to be sold and the proceeds are to be divided equal between Minnie Ann Hammontree & my estate after the expenses of sale are made & paid

I give to my grandson Foute Fields Hammontree Fifty dollars (\$50.00)

I give to my granddaughter Mary Lee Hammontree Fifty Dollars (\$50.00)

I give to my grand daughter Hazel Wilmit Hammontree Fifty Dollars (\$50.00)

I give to Bobby Cathaleen Hammontree Fifty Dollars \$50.00

I give to Hetty Ellen Hammontree. (my grand daughter) Five Hundred dollars (\$500.00)

I give to Fred Elmer Hammontree, John Wesley Hammontree and Cecil David Hammontree each Five Dollars.

I want my Grandson Samuel Tulloch Hammontree to have the remainder of my estate after the expenses are all paid.

I want Hetty Ellen Hammontree to have a bed pillows & bolster, bed stead, dresser & wash stand, & andirons.

I want Samuel Tulloch Hammontree have a bed pillows & bolster, also bed stead.

I want Hetty to have my flat top trunk and contents, Hetty is to get the organ.

ISABELLA M. SHEDDAN.

I, Isabella M. Shedden of the village of Friendsville, in the County of Blount, State of Tennessee, being of sound mind and disposing memory do make and publish this my last will and testament, hereby revoking all former wills made by me.

First- I will and devise to my niece Lizzie Monroe and her husband, George W. Monroe- all my real estate situated in the village of Friendsville, Tennessee- being the property where I now reside & lot adjoining same; This is conditional that the said devisees, Lizzie and George W. Monroe shall pay to the Friend's Monthly meeting or Church, at Friendsville, Tenn. Five Hundred Dollars, within one year after my decease, and if not paid by that time it shall draw interest till paid.

Second; I will and bequeath to the Friend's Monthly Meeting or Church Six Hundred Dollars- Five Hundred dollars of which is to be paid by Lizzie and George W. Monroe, as provided in the first item of this instrument and is to be used by said monthly meeting or church, preferably by me, in providing a parsonage for the church- but may be used differently of the Monthly meeting so desire, but only for Church purposes- The One Hundred Dollars to be paid to said monthly Meeting or church by my Executor, and shall be held by in trust- and loaned out, and the interest therefrom shall be used for the purpose of keeping the graves of myself and my husband, John E. Shedden in a neat and attractive condition.

Third;- I will and bequesth to the United Presbyterian Church at Big Spring- of which church I am a communicant, in Blount County, Tenn. One Thousand (1000) Dollars.

Fourth; I hereby authorize my executor to have placed around the old Sheddan burying ground on the farm of Joseph McCall, in the Second district of Blount County- a good wire fence to cost not exceeding one hundred dollars.

Fifth; I hereby make the following bequests, viz;

To Mary Beals, John C. Beals, Charles Beals and Emma Allen children of my deceased sister, One Hundred dollars each, and

To Frances Isabella Beals- daughter of my nephew John C. Beals of New Mexico- Two Hundred dollars; To be paid by my Executor to her father, John C. Beals, taking his receipt for same, and it is my wish that her father shall invest said sum & take care of it for her benefit.

To Holten Monroe and Joseph Beals- my grand-nephews One Hundred dollars each- to be paid to their father and guardian respectively & held by them in trust.

Sixth; I will and bequeath to my three nieces, Lizzie Monroe, Mary Beals and Emma Allen- all my household and kitchen furniture and furnishing- and whatever live stock I may have on hand at the time of my death.

Seventh; All the balance of my estate, I will and bequeath to the Directors of Maryville College- after the payment of my debts and funeral expenses.

Eight; I hereby appoint \_\_\_\_\_ Executor of this my last will and testament- and such is my confidence in him that I hereby release him from making bond- but he must make reports and settlements as required by law.

Ninth; I will and bequeath to Sarah Elizabeth Allen, daughter of my niece Emma Allen of California- One hundred dollars- to be paid by my Executor- to her mother for her use and benefit.

To this my last will and testament I affix my name this January 27, 1912.
