## Batte of Virginia

Lineage. Henry Batte, the son of Henry Batte and his wife Margaret (Waterhouse) Batte, was born 155/1586 of Okewell, Yorkshire, England, died 1555. He was married to Mary Wilkinson of Yorkshire, a daughter of Richard and Alice Wilkinson. They had three known sons, viz. Henry, Richard and Robert (chr. 7/6/1560 Okewell Hall, Yorkshire, England, Near Bristol-1617).

Henry Batte, son Henry Batte of Okewell, England, was from Bradford, Yorkshire, England and married a daughter of Richard Wilson. Issue. Robert, Henry and Richard.

Robert Batte, son of Henry Batte, was married to Mary Parry, daughter of John Parry and had by her William, Henry and John Batte.

John Batte, son of Robert, emigrated to America, chr. 6/24/1606 on Newton Tony, Wiltshire, England, died 1652 in Henrico or Charles City County, Virginia. Wife, Martha Mallory, a daughter of Thomas Mallory. The first record of him in Virginia is a 1643 land patent in Charles City County, Virginia. On 8/29/1668, Sir William Berkeley granted to Thomas and Henry Batte, sons of Mr. John Batte, deceased, 5,878 acres on the southside of the James River in Appomattock in Charles City County, beginning at the head of Jordan's land and Merchant's Hope, on the southern branch of Charles City Creeke, for the transportation of 118 persons into the Colony. Among those listed were: Roger Mallory, William Batte, Jr., Martha Batte, John Batte Jr., John Batte Sr., Thomas Batte, Henry Batte, Philip Mallory, Nathaniel Mallory, Nathaniel Mallory, Thomas Mallor and Elizabeth Mallory. - Henry Batte, chr. 2/9/1644 in Bristol Parish, Yorkshire, died 1702 in Prince George County,
  Virginia. He was married to Mary Lounds, a daughter of Henry and Ann Lounds. Issue.
