

Beckham of Virginia, North Carolina & Georgia

Simon Beckham, emigrant to Virginia died 9/1716 in Essex County, Virginia. The 1704 Quit Rent Rolls of the Colony of Virginia show Simon Beckham of Essex County as the owner of 100 acres.

Essex County, Virginia Order Book No. 3, 1703–1706, page 89.

“10 July 1704. Certificate according to Act of the Assembly, granted to Simon Beckham for 50 acres of land due by his the said Beckham’s own transportation into the Colony, who, in Court assigned the same to Larkin Chew. Larkin Chew is believed to have speculated in land, as he received patents for 2,700 acres.”

An inventory of the Estate of Robert Halsey, deceased, taken by Court Order on 10 November 1703, Simon Beckham’s name appeared as being obliged for 700 pounds of tobacco. Essex County Wills and Deeds, Vol. 11, 1702–1704, page 218.

The Last Will and Testament of Simon Beckham probated on 9/19/1716 is recorded in Essex County, Virginia Deed and Will Book 14 (1711–1716), page 665.

William Beckham, a son of the above Simon and Lydia Beckham, was born ca 1680, emigrant to Virginia, died in Essex County, Virginia on 9/1716.

William Beckham, son of William (above), was born ca 1680 and was a resident of Essex County, Virginia. He emigrated to Orange County, Virginia ca 1701. Wife, Tabitha.

Middleton, James Talbert. The LWT of Thomas Beckham was probated the January Term of 1796 in Edgefield C., S. C. and named his wife, Mary and children. Issue:

4. William Beckham, Captain during the Revolutionary War, was born 1734 in Buckingham County, Virginia, died 9/9/1812 in Columbia County, Georgia. Wife, Catherine. Captain Beckham purchased 160 acres of land on Greenbriar Creek in Columbia County, Georgia on 2/9/1794. His will named his grandsons, Thomas and Lewis Cobbs, son of John Cobbs, deceased. Grandson: Alfred, Simpson and G. Beckham Ellis, children of Charles Ellis. Granddaughter, Catherine Cobbs. Great grandson: William Beckham. Great granddaughter, Adeline Cobbs, daughter of Thomas Cobbs. Also named Polly W. Cobbs, wife of Thomas Cobb. Issue:
