John and Charlotte (de Jolie) Bertrand. He fled from France during the persecution of Louis XIV; went to England from thence came to America and was advanced a Clergyman of the Church of England. The widow Ewell m. (second) 16th February 1724, William Ballendine of Lancaster County, Virginia; m. (third) Maj. James Ball."
